**Policy** 

ASSIGNMENT; TRANSFER

The Superintendent/Principal shall make certified staff assignments in the manner best calculated, in his/her judgment, to enhance the educational program.

Teaching, supervisory, administrative and support personnel are subject to assignment and transfer after recommendation of the Superintendent/Principal and approval by the Haworth Board of Education. Procedures for such transfers shall comply with provisions of current negotiated agreements and state and federal law. Disciplinary transfers are prohibited. Particular attention shall be paid to ensuring to the extent possible that there shall be equivalence of teachers and administrative staff among the schools. Discrimination in assignment, transfer and promotion shall not be tolerated (see 2224, 4111 and 4111.1).

Assignment of staff to extra-curricular activities shall be matched whenever possible with the appropriate skills and abilities.

In the determination of requests for voluntary reassignment and/or transfer, the wishes of the individual teacher may be honored to the extent that the transfer does not conflict with the instructional requirements and best interests of the district.

The district board of education shall ensure equal pay for equal work among members of the district's staff regardless of race, color, national origin, ancestry, age, sex, affectation or sexual orientation, marital status, domestic partnership status, familial status, liability for service in the Armed Services, atypical hereditary cellular or blood trait or refusal to submit to a genetic test or make the results of a genetic test known.
