a. WHEREAS, the Haworth Board of Education (hereinafter referred to as the "Board") advertised for bids for the Haworth School Roof Replacement Phase 2 (hereinafter referred to as the "Project"); and

WHEREAS, on May 13, 2014 the Board received four (4) bids for the Project as reflected on the attached bid tabulation sheet; and

WHEREAS, the lowest responsible bid for the Project was submitted by Clifton & Clark, Inc. (hereinafter referred to as "Clifton & Clark") with a base bid in the amount of \$449,000.00; and

WHEREAS, the bid submitted by Clifton & Clark is responsive in all material respects and it is the Board's desire to award the contract for the Project to Clifton & Clark;

NOW, THEREFORE, BE IT RESOLVED that the Board hereby awards the contract for the Haworth School Roof Replacement Phase 2 to Clifton & Clark, Inc. in a total contract amount of \$449,000.00.

BE IT FURTHER RESOLVED that this award is expressly conditioned upon the contractor furnishing the requisite insurance certificate and labor and materials/performance bond as required in the project specifications, together with an AA201-Project Manning Report, an executed A-101-Standard Form of Agreement Between Owner and Contractor and an executed A-201-General Conditions of the Contract for Construction, as prepared by the Board Attorney, within ten (10) days of the date hereof.

BE IT FURTHER RESOLVED that the Board Attorney is hereby directed to draft the agreement with the successful bidder consistent with this Resolution and with the terms contained in

the bid documents approved by the Board for the Project. The Board President and the Board Secretary are hereby authorized to execute such agreement and any other documents necessary to effectuate the terms of this Resolution.

a. WHEREAS, the Haworth Board of Education (hereinafter referred to as the "Board") advertised for bids for the Haworth School Hawk Hall Boiler & UV Replacement Project (hereinafter referred to as the "Project"); and

WHEREAS, on June 25, 2014, the Board received five (5) bids for the project; and WHEREAS, the lowest bid, in the amount of \$486,872, submitted by Reiner Group, Inc., is substantially in excess of the cost estimates prepared by the Architect and, as such, is unreasonable as to price;

NOW, THEREFORE, BE IT RESOLVED that the Board hereby rejects the bids received for the Haworth School Hawk Hall Boiler & UV Replacement Project pursuant to N.J.S.A. 18A:18A-22 (a) as the bids substantially exceed the cost estimates and, as such, are unreasonable as to price on the basis of the cost estimates prepared on behalf of the Board; and

BE IT FURTHER RESOLVED, that the School Business Administrator is hereby authorized to re-advertise the project consistent with the needs and desires of the school district.
