Mrs. Zelman – speaking on behalf of the Haworth Music and Arts Foundation and the .5 music position, looking toward the future. We're thrilled we are getting a replacement, but our main concern, coming from a town with many musicians and many artists, we continually hear we have to raise our test scores. The focus is on testing, but we need to put more of the focus on the arts. Looked at Bergenfield – majority of students there do not take private lessons. Majority of music exposure is in school. They have dedicated music professionals. This position should be a full-time position; kids should get music more than once a week. They need exposure at least two

times per week, if not more. We would like to see the music position for the future incorporated at least two full-time teachers. Look at curriculum and determine what we can do to work with the type of students we have.

- Mr. Sutnick: We have a thriving music and arts program in our school. Outstanding vocal and instrumental program. We are very excited about the future. Certainly the administration looks at this every year to see what the needs of our students are. We have very active musicians in our town we've begged and encouraged them to have a recreational music program. Quite honestly, nobody has ever stepped up to do that. Our school does everything it possibly can. Our concerts are exceptional. Our students are award-winning. To test prep, my comment is we didn't invent the PARCC test, we didn't enact it or vote on it. If parents have an issue with the incredible amount of standardized tests our children have to take, contact the governor and ask why our children are put under this much stress.
- Mrs. Bain: I beg to differ about the thriving music program we have. I get to see two sides of a class. My 7th graders one had an elective to sing and the other didn't. One missed out completely. That's not okay with me. I think it's an important time right now that we find someone who really is the right person that they are certified in certain things. Music can open up the door for every child to learn and grow.
- Mr. Sutnick: We've hired someone. She has been involved in our school before. We have pretty extensive dealings with her.
- Dr. Nuccetelli: She has certifications.
