M. Doran: We met on June 6th and we spoke about the Reader's and Writer's training that will be continuing into next year, which we are very excited about. We also spoke about the new Character Education and Social Competancy program from Olweus that will be implemented district-wide in the fall. We also spoke about the baseline needs of our school in that area and that there will be training this summer for a core team and in the fall the entire staff will be trained and there will also be a parent night. They also shared with us a Wilson Reading Fundations program that will be implemented in the fall for grades K-2, giving a multi-sensory approach to phonics instruction. Lastly, the Elevate Educate program was piloted this year in the 6th grade as that is the first year of middle school and the students already start a study skills program in that grade. The program was great so the plan is to unfold it to the 7th and 8th grades as well for this upcoming school year.

W. Sutnick: I would like to follow up on what was said earlier regarding Ms. Foglio. I think she is a wonderful teacher and when I saw on the agenda that she was leaving I was very, very disappointed. I know she received tenure this year, I know she arrives early every day and I know that she is very well liked by the students. I am very sorry to see her go but I do wish her well, of course.
