I wanted to find out how this went up so I went to your website and looked at the budget presentation. So I called Mr. Wolford and we had a nice meeting and he explained things to me. One of the things I had forgotton was that my tax levy is based on half of last years budget and half of this years budget. The presentation did not include this and I hope it does next year. Mr. Wolford also confirmed that there was a problem with debt service last year and now we have to raise this money to make up for this error.
