XIII. FACILITY

a. Approval of Affirmation of Declaration of Emergency – Haworth Public School:

WHEREAS, on or about January 1 through January 2, 2018, due to the inclement weather, the district experienced an emergency;

WHEREAS, Haworth Public School: On the evening of January 1, 2018: Boiler #3 shut down due to an ignition failure causing the pipes for the fire system in the library to freeze. On January 2, 2018 the boiler was reignited and the warming process caused sprinkler heads in the fire system to separate from the piping system. The breaks caused significant damage to one Kindergarten classroom, an ELL classroom, the Reading support classroom, library, one storage closet, the rear library stairwell, PD room, and the basement hallway;

WHEREAS, it has become necessary to immediately proceed with the repairs of the damages; WHEREAS, N.J.S.A 18A:18A-7 allows for the official in charge to declare an emergency and is then authorized to proceed to award a contract to satisfy the emergent need;

NOW THEREFORE, BE IT RESOLVED, that the Business Administrator hereby declares an emergency at the Haworth Public School with the respect to the need for immediate action to address the health and safety of the occupants, and has notified the Executive County Superintendent of Schools for Bergen County, New Jersey of this emergency and actions taken; and

BE IT FURTHER RESOLVED, that the Board authorizes the Business Administrator to negotiate and approve the award of a contract(s) for the repair and/or replacement of the damages to the lowest responsive quote or through a purchasing cooperative in which the district participates. NOTE: The claim has been filed with the district's insurance company.

S. Wunsch: Updated the public on the progress of the repairs being done to the areas that had water damage due to the burst pipe. She also mentioned that the Facilities Committee discussed the morning drop off procedure and ideas to make it more efficient. Another topic was how to disseminate information to the parents more effectively.
