K. Leddy - inquired if there were any aides that were already part of the staff that could fill this position, or if the vote could be moved to a later meeting once we know if school will be virtual or not in September.

Dr. Hughes - explained that all of the aides have been working online and this particular hire is a 1:1 IEP driven aide. He added that it is not easy to fill spots late in the summer and that this position has been posted for two months already.

K. Leddy - suggested that costs be taken into account in this uncertain time, and as other salaries are being frozen.
