The Board President will recognize each member of the public individually when it is his or her turn to speak and will unmute his or her audio at that time. If a member of the public wants to provide a comment, but cannot access the "chat" he or she can verbally state their name, address, and group affiliation, if any, and the Board President will inform him or her when it is his or her turn to comment. The Board will also read written comments submitted in accordance with the Board's resolution. All public comments are limited to three minutes, including time for the Board to respond. At all other times, members of the public will be muted. The Board will follow its adopted bylaws, procedures, and resolutions with regard to conduct during the Board meeting, including during public comments.

VI. WORK SESSION TOPICS

- a. BOE member training Mr. Matthew Lee, New Jersey School Boards Association *Mr. Lee reviewed the CSA Evaluation process, which needs to be completed by 7/1/21.*
- b. Continued Facilities discussion (survey, outdoor space budget, air filtration system) Mr. Wolford explained that the building survey would be completed within 4-6 weeks, which is important to have for suture planning. He clarified that the air filtration system company is a state approved vendor, and some of the cost will be encumbered by ESSER II funds. The outdoor learning space cannot be reimbursed by ESSER II funds, but the administration believes it will be a positive addition for student learning. Mrs. Borek asked when a referendum would go out for a vote? Mr. Wolford responded that the Long Range Facilities Plan would need to be approved first, then the state would would have to review the referendum plan and approve, and then if approved, they would give us a figure on how much aid we will receive for it.
- c. Curriculum 2021-2022 (TC lite, STEAM, other) For the 2021-22 school year, the district will invest in more math professional development by using Nancy Schultz and other outside consultants. Teacher's College workshops will be offered for new teachers who are not already trained. More collaborative time will be given to the teachers as well. STEAM will offered as a part of the Summer Enrichment program, and will be the district's next area of focus.

- e. Discussion of virtual vs. in-person BOE meetings after June, 2021 Governor Murphy will require all meetings to resume in public once the public health emergency is lifted, which will likely be on June 13, 2021.
