VI. WORK SESSION TOPICS

a. COVID Health Protocol Discussion - Dr. Nancy Rothenberg & Dr. Hilary Cohen 3 choices with the mask mandate:

- Optional without metrics
- Optional with metrics
- Leave mask mandate in place

Waiting for additional and more specific guidance from the state government.

Dr. Rothenberg, School Physician and Dr. Hilary Cohen, parent and community member Both doctors weighed in on their opinions regarding the wearing of masks in school. They both agree that if the level of community transmission continues to decrease, then the March 7th date to remove masks would be reasonable. If the transmission levels increase again, then bring the masks back. They also would like to see more specific guidelines from the state if an positive case is in the classroom, and then have guidance on quarantine and contact tracing protocols. They suggested that if the community levels are in orange or red on March 7th, then the mask should be required still and if the levels are yellow or lower, then make the masks optional. Have a timeline for reassessment of the trends. Keep the parents informed of all plans. Dr. Rothenberg suggested that the quarantine guidelines stay with what the CDC recommends, if the Governor does not make specific guidelines by March 7th.

b. Emotional Intelligence Proposal for Middle School

Series of workshops for the students with Lee Rouson, a former NFL player. There are eight sessions focused on creating students sense of purpose. This would go towards the goal of working on the social and emotional supports. The cost would be encumbered by ESSER funds.

c. District Website Discussion

Dr. Hughes has been evaluating different website companies. The BOE would like the navigation to be simpler and more user friendly, and the site to have a more modern look.
