"Projects");

WHEREAS, the School District will seek Debt Service Aid with respect to the Projects; and

WHEREAS, the Board now seeks to take the initial steps in order to proceed with the planning and authorization of: (i) the Projects; and (ii) a School District special election at which time a bond referendum authorizing the Projects shall be presented to the voters of the School District.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE BOROUGH OF HAWORTH IN THE COUNTY OF BERGEN, NEW JERSEY, as follows:

Section 1. In accordance with the requirements of Section 6A:26-5.1 through 6A:26-5.3 of the New Jersey Administrative Code, the Board hereby authorizes and/or ratifies the preparation of Schematic Plans and Educational Specifications, if required, by RSC ("RSC") in connection with the Projects and the Board further authorizes/ratifies and directs RSC to submit the same to the New Jersey Department of Education and to the Bergen County Superintendent of Schools for review and approval. The Board further authorizes and directs the submission of the Schematic Plans to the planning board for its review, to the extent required by law.

- Section 2. In accordance with the requirements of Section 6A:26-2.3 of the New Jersey Administrative Code, the Board hereby ratifies any amendments to the Long Range Facilities Plan, as necessary, to reflect the Projects and approves the submission of any such amendment to the New Jersey Department of Education.
- Section 3. In accordance with the requirements of Section 6A:26-3.2 of the New Jersey Administrative Code, the Board hereby authorizes and/or ratifies the submission of the Projects Applications and its decision seeking debt service aid for the Projects.
- Section 4. With respect to the Projects, the Board hereby authorizes and directs the Board President, the Superintendent and the Business Administrator/Board Secretary, as applicable, to execute the schematic plans and educational specifications, the amendment to the Long Range Facilities Plan, the Projects cost estimate sheets and all related Projects documents allowing submission of same to the New Jersey Department of Education.
- Section 5. The Board hereby authorizes and directs the Board President, the Superintendent, the Business Administrator/Board Secretary, RSC, and Wilentz, Goldman & Spitzer, P.A., as Bond Counsel, as applicable, to take all action required to preserve the opportunity to present the Projects to the voters via a bond referendum at School District special election to be held on March 8, 2022 or such other date as may be available to the Board.
 - Section 6. This resolution shall take effect immediately.

k. Whereas, the Board accepts the School Security Grant award from the New Jersey Department of Education in the amount of \$21,567.00. \$21,567.00 of this grant award was used for the installation of the Alyssa's Law compliant LENS lockdown/panic alarm system for the Haworth Public School which was installed in the 2018-19 fiscal year. The total project cost was \$25,996.00 Additionally, \$21,000.00 will be used to upgrade the District's surveillance cameras during the 2021-2022 school year.

Be It Resolved, the Board affirms local funds were available and utilized during the 2018-19 fiscal year for the Alyssa's Law compliant LENS lockdown panic alarm systems in the Haworth Public school for a total project cost of \$25,996.00.

Be It Further Resolved, that the Board affirm acceptance of the Security Grant for Alyssa's Law for the reimbursement of the usage of local funds in the 2018-19 fiscal year to complete the installation of the Alyssa's Law compliant LENS lockdown/panic alarm system and the reimbursement of usage of local funds in the 2021-22 fiscal year to upgrade the District's surveillance camera system. The total project cost for both of these projects exceeded the Board's grant allocation of \$21,567.00.

The Board members agreed that the district will not be accepting anymore tuition students for the remainder of the 2021-22 school year.
