VI. SUPERINTENDENT'S/BOARD PRESIDENT'S REPORTS

HAWORTH BOARD OF EDUCATION MINUTES - 9-14-21

a. Honoring the work of our Summer 2021 Workers

Dr. Hughes showed a slide show of pictures of the building from the end of the last school year to the beginning of this year, highlighting the hard work of the custodial staff.

b. "Building Renovation Construction Proposal" presentation - RSC Architects Mr. Rodino introduced RSC Architects to speak about the future building plans, the process and the reasons as to why a referendum is being proposed for improvements to the district facilities.

Dr. Hughes showed visual examples of what the completed projects would look like.

Mr. Rodino clarified the financial reasons as to why it is a good time for the district to pursue a referendum.

Deborah Munoz, 110 Schraalenburgh Road - questioned the library renovation and asked how long the students would be without a library space.

RSC Architects explained that it would be a two phase project and the existing library would still be available while the new space is being constructed. He explained that the library project would have an 8-12 month impact on the building.

Dorothy Klain, 350 Whitman Street - inquired about Policy 5111 for accepting tuition students. What is the criteria we are looking for in order to take these students? What is the cost to attend?

Mr. Rodino explained the policy allows for us to admit students on a tuition basis as long as we have the capacity to do so. They are evaluated and approved by the BOE on a case by case basis depending on class size or middle school team. The cost per middle school student for the 2021-22 school year is \$22,500.00. An unprecedented event happened in a neighboring town and we would like to help if we can.

Steve Miskovitz, 331 Harrison Street - question about the anticipated cost level of the referendum and what it includes?

RSC Architects explained that the cost will cover the physical construction including furniture, fixtures, wiring, and anything related to the building itself. The operating costs are separate.

Dr. Hughes explained that the Pre-K will incur personnel costs, but as it also revenue driven, it will make a profit for the district.

Ray Wang, 138 Beacon Street - inquired about the Pre-K, when would it be ready, how much would it cost and would it be offered to anyone in town or will there be a cap on class size?

P. Wolford we surveyed the other programs in the Valley and the average class size is 15-20 students, with a cost of 10,000-11,000 per student. Hoping to open the doors for the 2024-25 school year.

Marianne Groh, 240 Haworth Avenue - concerned that the Strategic Plan did not cover many of these current projects. She wants to make sure that these projects have been in the pipeline for a while. Would like to see the comparisons of the past and current enrollment. Also, does not believe that the expansion of the gym is necessary. Asked if the other Valley districts that offer a Pre-K program are single building K-8 schools?

Deborah Munoz, 110 Schraalenburgh Road - questioned if the architect considered additional parking with the plan?

RSC Architects explained that the building additions will not have a negative impact on parking and therefore there is not a need for additional spaces.

Alicia Walker, 76 Pleasant Street - asked if it was possible to know how the additional revenue from the tuition students would be spent?

P. Wolford explained that tuition monies goes into the general fund since it was not appropriated within the original budget. It would go towards additional programming and any other building needs, for example we needed additional staffing this year for the extra lunch periods due to COVID. If the money does not get spent then it rolls into the capital reserve to be used in emergency situations.
