S. Wunsch - shared that she attended the High School BOE meeting and she summarized that the presentation done by the Principal noted that their HIB cases have gone down dramatically, as well as their incidents of sending students out for drug testing. They also did a presentation on their technology and their updates on security measures. Overall it was a positive meeting and the biggest take away was their technology improvements. There was mention that they are also having issues with out of district transportation and insurance costs and it has significantly impacted their budget.

Mr. Wolford shared that the transportation costs increasing exponentially is because of a shortage of busses due to company mergers amongst other things, as well as a shortage of licensed bus drivers. He also noted that insurance costs have gone up dramatically and that this is an issue throughout the entire state.

S. Wunsch - explained that a Memorandum of Agreement between the school district and the police department is established every school year to review the procedures for school safety.
