

We are beginning the process of planning the ASB budget for the 2019-2020 school year. This process begins with input from your club(s). Please take some time to talk with your student leadership team to determine what your financial needs will be. As you discuss this, keep in mind that your budget requests to ASB should include:

**REVENUE FORECASTS**: Fundraisers you are planning and how much you hope to make, fees that your club will charge, money you earn from camps, etc..., and donations or other income.

**ANTICIPATED EXPENSES**: Supplies, refreshments, decorations, travel expenses (including hotel, meals, and transportation), contract services (DJ, choreography, etc...), registrations, custodians, etc...

When preparing your annual budget, please keep these things in mind:

- 1. By law, ASB cannot exceed its budget. Please plan wisely and include any and all expenses that COULD incur during the school year.
- 2. Include estimations for ALL possible revenue sources and ALL possible expenses.
- 3. The ASB Budget Committee (students and staff) will make decisions based on the specific information you provide. If you feel an explanation is needed, please type up a memo to the committee and submit it with your ASB Budget Worksheet. Or, you may request to give an inperson presentation to the student council.
- 4. ASB funds CANNOT be used for curricular purposes or materials.
- 5. ASB funds CANNOT be used for private use or gifts.

#### \*\*Reminders\*\*

- -In order to receive ASB funding, all club participants must purchase an ASB card.
- -All clubs must have a constitution on file in the ASB Advisors office to be considered active.
