



When New York City is excluded:

- Long Island educates nearly 17% of the state's students.
- Only 12% of state aid is directed to Long Island schools.
- Long Island state aid per pupil is \$5,949, which is 26.7% less than the rest of the state (\$8,113).

Rules for Contingency Budget

- If the budget is defeated twice, pursuant to NYS Tax Cap legislation, there can be no increase in the tax levy – 0.0%.
- Thus a defeated budget will require that the tax levy be **reduced** by \$1,356,293 and the budget for 2018-2019 by the same amount.





Proposition Three – Capital Reserve

Proposition 3

This proposition authorizes the school district to expend funds from the capital reserves on a variety of capital projects at all buildings in the district

Approval of this proposition results in no additional cost to the taxpayers.
