4. Discussion and Possible Action on the Lunch Prices for 2018-2019

Motion by Mr. Giglietti, Second by Dr. Turner to recommend the Amity Board of Education authorize the food service provider to raise lunch prices at Amity Middle School Bethany, Amity Middle School Orange, and for pizza meals at the Amity Regional High School by 20 cents to \$3.00 for 2018-2019, and the Director of Finance and Administration is authorized to approve increases in a la carte items.

I recommend the following contracts over \$35,000 be awarded by the Amity Board of Education in accordance with the Board's Policy on purchasing procedures:

1. **Cybersecurity Assessment:**

The District went out to bid for an assessment of the security of cyber systems, a digital audit. 21 bids were received. The prices ranged from \$2,950 to \$ 194,450. 14 of the 21 bids received were under \$35,000. The bids are still under review but I am confident we will be entering a contract under the \$35,000 threshold requiring Board approval. Once a detailed review is complete and references checked a purchase order will be issued to the selected vendor.

2. **Laptop Devices for 1:1 initiative:**

The District went out to bid for 430 laptops with touch and non-touch screen options. 3 bids were received. The prices ranged from \$182,320 to \$207,745. After a review of the products, pricing, references and other specifications, Shaun DeRosa, the Director of Technology, has recommended Whalley Computer Associates, Inc. of Southwick, MA at a price of \$182,320 over a 3-year lease. Whalley Computer, Inc. is the low bidder. There is \$150,000 in 2018-19 budget for 1:1 implementation.
