Dear Parent and Guardian:

For the 2024-2025 school year, Ferris ISD Food Services will transition to a new online payment system for meal accounts used in the cafeteria. The current system, MySchoolBucks, will no longer be available for making payments, checking balances, and cafeteria purchases.

This new system is called **School Café** and can be accessed by going to <https://www.schoolcafe.com/FERRISISD>. Parents are encouraged to go to this site and create an account beginning July 8th in preparation for the switch to **School Café**.

PLEASE NOTE: All account balances will be transferred from MySchoolBucks to School Café by July 19th, and you will be able to add your student's account and make online payments on your newly created School Café account at that time.
