# HISTORY OF SAMUEL W. TUCKER ELEMENTARY SCHOOL

Samuel W. Tucker Elementary School opened its doors to our students and families on September 5th, 2000. This was a milestone event in the city of Alexandria, as Tucker Elementary was the first new school to be built in more than thirty years.

During the summer of 1999, a School Board appointed School Naming Committee recommended that the school be named in honor of Samuel Wilbert Tucker (1913-1990), a distinguished lawyer and civil rights activist who was born and raised in Alexandria. On November 16th, 1999, the School Board voted unanimously to name our school Samuel W. Tucker Elementary School. It is a name that all Tucker students and staff members are proud to have. All of our students learn about Samuel W. Tucker during the first few weeks of school.

On October 19th, 2000, the tenth anniversary of Mr. Tucker's death, Samuel W. Tucker Elementary School was officially dedicated. School Board Chairman Steve Kenealy expressed confidence that Tucker Elementary will live up to the grand expectations of the man for whom it is named. "It's a school that brims with excellence and grand hope for the future, as well as educates and celebrates children from all walks of life." Following his remarks, Dr. Kenealy, Dr. Berg (superintendent), and Mrs. Elsie Thomas, Samuel Tucker's sister, unveiled the portrait of Mr. Tucker that still hangs in the entryway of the school.

#### Extended Learning/Intersession:

With the adoption of the Fiscal Year 2025 budget, the ACPS Board of Education approved funding for the following fee structure:

Eligible Free/Reduced Lunch Participants (EBT & SNAP Eligible) -\$10 for each two-week session

Full Pay Participants-\$125 for each two-week session

All students are strongly encouraged to participate in Extended Learning Time opportunities. Each day will focus on both acceleration and enrichment. The acceleration portion of the day will be used to preview the curriculum for the following grading period. The other portion of the day will be focused on improving student achievement in literacy and mathematics through enrichment activities.

# Arrival at School

<u>Walkers:</u> All students walking to school will be directed to walk along the townhouses to the gym entrance to avoid congestion at the Parent Drop off doors.

<u>Parent Drop-Off</u>: Parents driving their children to school are asked to use the **Parent** Drop-Off area at the Ferdinand Day Drive entrance when dropping students off in the morning. Please do not leave your car unattended in the Kiss and Ride (Parent Pick up) area, as this is also a Fire Lane, and no parking is allowed. Please do not park along the fence by the big field.

Kindergarten Drop-Off: All parents dropping off Kindergarten students should do so at the Kindergarten Playground.

**<u>Bus Loop:</u>** The bus loop is located on Cameron Station BLVD and is exclusively for buses. Cars are not permitted to stop or park in the bus loop at any time.

Late Arrivals: Please park your car in the parking lot area and walk your child into the building if you arrive at or after 8:00 a.m. Children who are tardy to school must be signed in with the attendance clerk by the parent or guardian. Please use our computer sign-in station.

<u>Walkers and Bike Riders in the Cameron Station Neighborhood:</u> Our students living within a 1-mile radius of the school and in the Cameron Station neighborhood may walk or ride a bike to school.

Residents living on the South side of Cameron Station Blvd are encouraged to walk on the street and follow it down to Tucker. Residents living on the North side of the street are encouraged to stay on the North side until reaching the crossing guard at Picosin Lane and Cameron Station Blvd., where they can safely cross to the South side of the street. Bike riders should use the bike path, while walkers use the community sidewalks. An additional crossing guard will be stationed on Ferdinand Day Drive to facilitate students crossing the street to the cafeteria entrance. Staff members will also assist walkers in this area.

# Hours of Operation

Regular school hours are 8:00 a.m. to 2:35 p.m.

Classrooms open at 7:45 a.m.

All students must be seated in their classrooms by 8:00 a.m. Academic instruction begins promptly at 8:00 a.m.

Breakfast: Breakfast is from 7:40 a.m. until 8:00 a.m.

Early Dismissal School Days: School hours are 8:00 a.m. until 12:35 p.m.

# Attendance Policy and State Law

Poor school attendance often results in less than satisfactory academic progress. Therefore, we strongly discourage families from taking vacations during school days. Every absence impacts your child and their classroom, and extended absences have been shown to harm a student's education. Consistent and punctual attendance is key in ensuring a child's academic success. Please help us help your child succeed in school by:

- Sending your child to school on time every day, unless they are have a temperature of over 100°F, are vomiting, or have diarrhea;

- Scheduling family vacations and travel around the school calendar;
- Scheduling doctor and dental appointments around school hours;

Parents, please verify with your child's teacher that your child has completed all "missed work."

Parents, please try to notify the main office of your child's absence by 8:30 a.m. Send a written note explaining the absence to their child's teacher when they return to school.

**Excused absences** are granted for two reasons: **illness and family emergencies**. In each instance the absence must be verified with a note from parents or guardians when the child returns to school. Absences for any other reason are considered unexcused.

#### There is no expectation that teachers provide work during a planned absence.

**Excused absences:** Per the **Virginia Administrative Code (8 VAC 20-730-10)**, student absences may be excused pending verification from the parent/guardian or another designated professional. Examples of excused absences may include but are not limited to the following conditions:

**a.** Medical Illnesses (Physical or Mental). A principal must request that documentation from a physician be provided after the student has accrued three consecutive absences or ten or more absences within a given school year.

- **b.** Medical and dental examinations.
- ${\boldsymbol{\mathsf{c}}}.$  Observance of a religious holiday.
- ${\bf d}.$  Student court hearings.

e. Students who have been approved to participate in school-sponsored activities (inside and outside the school building).

f. Students who have been assigned In-School (ISS), Alternate Instructional Support (AIS) Center, or Out-of-School Suspension (OSS).

**g**. Family emergencies (loss of a loved one, unexpected residence dislocation, critical injuries to family members, etc.). Parents/guardians are expected to plan extended travel and vacation days around ACPS scheduled breaks and approved holidays.

h. ACPS transportation services-related delays.

i. Civic Engagement for secondary students (one school day per school year).

**Pre-Arranged Excused Absences Pre-Arranged Absences:** Request Forms may be submitted in specific situations. Examples of activities that may constitute a pre-arranged excused absence include, (with documentation), but are not limited to:

- a. Visitation with family members deployed in the US Military and Armed Forces
- ${\bf b}.$  Visitation with incarcerated caregivers
- c. Appointments with military recruiters
- d. Appointments with college/university admissions departments,

e. School students, ages 12 and under, who cannot be left at home alone/unsupervised while a parent/guardian is on professional travel for employment-related activities.

Pre-Arranged Absences Request Forms <u>must</u> be submitted **at least five days prior** to the scheduled absence, and advance approval of each pre-arranged absence must be granted by the school administration. In addition, documentation of a student's participation in the above noted activities must be provided no later than three days after the event is complete.

**Please Note:** After 15 consecutive days of absences (excused and unexcused), your child's placement at Tucker will be lost. Re-registration will be required in order to return to school, in which your child might be placed on our waiting list.

#### Before and After School Services and Activities

**Extended day care** is available through the Campagna Center, One-Kick Martial Arts and Patrick Henry Recreation. Children are supervised in the cafeteria from 7:00 a.m. to 7:40 a.m. and again from 2:35 p.m. until 6:00 p.m. For more information about these programs, please contact them at:

#### After School Activities

The Tucker PTA will offer after school programming twice a year. Additionally, after school academic support will be offered to selected students. Afternoon activity buses provide transportation home at the conclusion of the activity.



#### **Dismissal Procedures**

School is dismissed at 2:35 PA

Early dismissal time is 12:35 PM

#### Parent Pick-Up:

Parents who pick their children up in the afternoon, please park your cars in the school parking lot or at Booth Park and come to the Pavillion. Students will exit from the Gym doors. Kindergarten student pick-up is located at the Kindergarten playground beginning at 2:35.

#### **Bus Loop:**

The bus loop is located on Cameron Station Blvd and is **exclusively** for buses. Cars are not permitted to stop or park in the bus loop at any time.

#### Change in Pick-Up time for your child(ren):

Early dismissals are disruptive to classroom instruction, learning, and the staff preparing for a quick and safe dismissal. If you need to pick up your child early because of an appointment, please send a note or message to your child's teacher, phone the main office, or email us **before 12pm** whenever you need to pick your child up before 2:35 p.m. or whenever you need to change your child's after school plans. We <u>will not</u> and <u>do not</u> accept change in dismissal from students. Change in dismissal procedures **MUST** be in writing or with a phone call. Your child will be called when you arrive. We suggest arriving 10 minutes prior to when you need to leave to give your child time to collect their belongings and leave class. We <u>cannot</u> have your child waiting in the office for you.

Regular established dismissal procedures will still be followed if any calls to the school to change those plans are past 12pm.

Anyone picking up a student from the school must be listed on the student's emergency profile in PowerSchool and must provide a photo ID.

# **Dismissal Tags for our Kindergartners**

According to Alexandria City Schools policy, kindergarteners will receive a green sticker bus label indicating that they are Kindergarten or "K" students. This sticker label will alert the bus driver that an adult must meet the child at the bus stop for pick up DAILY. If no parent or guardian is present to receive the kindergarten child, the child will be returned to the school; the child's parent will be contacted to pick up their child.



#### **Emergency Announcements**

#### During delays, students should report to school at the following times:

#### **Delays for Bus Riders**

**1-hour delay:** Arrive at your bus stop one hour <u>later</u> than usual. For example, if your bus typically arrives at 7:20am, you should arrive at your child's bus stop at 8:20 a.m. **2-hour delay:** Arrive at your bus stop two hours <u>later</u> than usual. For example, if your bus typically arrives at 7:20am, you should arrive at your child's bus stop at 9:20 a.m. Inclement weather will occasionally require a one-hour or two-hour early closing. Parents, please make arrangements for child care in these types of emergencies. If your child attends the Campagna program, please refer to the Campagna Parent Handbook or call 703-224-2382 for policies related to early school closure.

# Moment of Silence

In compliance with the laws of the state of Virginia and the Virginia Code: § 22.1-203,

Daily Observance of One Minute of Silence: In order that the right of every pupil to the free exercise of religion be guaranteed within the schools and that the freedom of each individual pupil be subject to the least possible pressure from the Commonwealth either to engage in, or to refrain from, religious observation on school grounds, the school board of each school division shall establish the daily observance of one minute of silence in each classroom of the division.

During such one-minute period of silence, the teacher responsible for each classroom shall take care that all pupils remain seated and silent and make no distracting display to the end that each pupil may, in the exercise of his or her individual choice, meditate, pray, or engage in any other silent activity which does not interfere with, distract, or impede other pupils in the like exercise of individual choice. The Alexandria City Public School Board has adopted **Policy IE**. This policy requires all schools to begin the day with a mandatory moment of silence. All students, staff, and guests in the building observe this time by remaining silent for the specified sixty-second period. Students are permitted to engage in any silent activity which does not interfere with, distract, or impede others.

## **Dress Code**

Students will wear seasonably appropriate clothes to school.

**The Alexandria City Public Schools Course Assignments Policy** is the basis for Tucker's practices. Course assignments outside are integral to a student's learning experience because it strengthens basic skills, fosters independent study habits, extends classroom learning, provides enrichment and remedial activities, and develops responsibility, initiative, and self-discipline. Parents can help make this effective by setting a defined time and suitable place for study, encouraging independent completion of assignments, fostering a positive attitude towards a task, and providing guidance or help when necessary. Assignments are regularly given in grades one through five. Children typically are given work four nights per week, Monday-Thursday. An assignments, initial the appropriate box, and return the form daily. In addition, kindergarten children will take home reading assignments and suggestions for enrichment activities Monday through Thursday evenings.

## **Class Placements**

This year, we have worked very hard to ensure the balancing of classes. Careful consideration has been given to input from staff and families, as well as student learning styles. Our classrooms have been balanced both academically and socially, and our class lists are structured to provide equitable class sizes at each grade level. Moving students is difficult without causing imbalances and inequities. Class placements are determined with thoughtful consideration of input from staff and families, as well as the diverse learning styles of students. Our goal is to create balanced classrooms both academically and socially, ensuring equitable class sizes at each grade level. Therefore, requests to move students are challenging and may lead to imbalances and inequities.

# **Breakfast and Lunch**

Samuel W. Tucker Elementary School has been selected to participate in the Community Eligibility Provisions (CEP) Program for the 2024-2025 school year. CEP is a non-pricing meal service available to schools. Under the provisions of this program, all students will receive the option of free breakfast and lunch daily. Parents may still put money on their child(ren)'s accounts at <u>schoolcafe.com</u> if they want their child(ren) to have the option of purchasing additional snacks for lunch.

#### Outside Food in the Cafeteria

We strive to keep a healthy, positive atmosphere in our school cafeteria. If your child is not eating school lunch, please feel free to send healthy food for lunch. **Meals from "fast food" restaurants are not permitted**. Other students often feel left out and distracted when such lunches are brought to school. Thank you for cooperating in fostering healthy eating habits for all our children.

#### <u>Please do not pack carbonated drinks or glass containers in lunches made at</u> <u>home.</u>

#### **Birthday Celebrations in Classrooms**

No Food or balloons are allowed for birthday celebrations on campus. This expectation will be consistently enforced, with no exceptions. Please discuss ideas for recognizing your child's birthday with your child's classroom teacher ahead of time. Your child's teacher may suggest unique ideas to celebrate your child's special day.

#### Lost and Found

Articles lost by students will be kept on the coat racks across the main office where students or parents can claim them. Parents, please label book bags, backpacks, lunch boxes, jackets, and other personal items to ensure their timely return to the appropriate students. Unclaimed items will be donated after a reasonable length to a charitable organization.

## Parent-Teacher Association (PTA)

The students of Samuel W. Tucker Elementary School benefit from the efforts of a very active and supportive PTA. Its members work hard to support, extend, and enrich the educational program for every Tucker student.

PTA Meetings are usually held on the second Monday of the month, beginning at 7:00 p.m. We encourage you to participate actively in the Samuel W. Tucker P.T.A. ## **Progress Reports**

ACPS believes that the evaluation of students is the primary responsibility of the professional staff. Grades are a tool for communicating the level of academic achievement with identified standards. These regulations aim to systematize grading and assessment practices across the school division. Grades serve as a means of establishing clear learning targets and providing students with feedback regarding their academic performance.

Following Policy IKC, the following regulations should guide and inform the evaluation of student progress as reflected in the grading process.

## Kindergarten

The ACPS Kindergarten Progress Report is organized using a scoring rubric. The rubric reflects the student's progress toward mastering specific skills taught during kindergarten.

ACPS uses a modified standards-based progress report for students in grades one through five. Its purpose is to provide parents and guardians meaningful feedback about how their child is doing in relation to grade-level standards, including their child's progress over time. Aligned with the Virginia Standards of Learning and the ACPS Curriculum, the ACPS Elementary Progress Report provides parents and teachers with detailed information on the expected knowledge, skills, and performance measures for students at each grade level and how individual children perform against those expectations.

Aligned with the Virginia Standards of Learning and the ACPS Curriculum, the Secondary Report Card provides parents/guardians with a letter grade detailing student performance for each quarter.

A. At the **Kindergarten level**, teachers shall give narrative feedback about students' standards-based progress within each identified area of the Kindergarten Progress Report. In addition, the range of performance indicators and the level of proficiency kindergarten students are expected to attain utilize the following scoring criteria: **Academic Areas Scoring Rubric** 

- M: Meets the standard consistently and over time
- P: Progressing toward meeting the standard

- B: Beginning to demonstrate progress toward meeting the standard
- N: Not demonstrating understanding of the standard\
- NT: Not taught this quarter
- INA: Standard has been introduced but not assessed

B. On **Elementary Progress Reports (grades 1-5)**, teachers shall give rubric-based scores reflecting students' standards-based proficiency. Content areas assessed include Life, Work and Citizenship Skills, Language Arts, Social Studies, Mathematics, Science, Physical Education and Health, Art, General Music, and Band/Strings.

- 4: Consistently demonstrates a high level of conceptual understanding and skills mastery of standards taught this quarter
- 3: Frequently demonstrates concepts and skills of standards taught this quarter

- NT: Not taught this quarter
- NA: Introduced but not assessed this quarter

#### Conferences

Parents are encouraged to communicate regularly with teachers concerning their child's progress in school. Report cards are sent home each quarter for all students. In addition, conference days are scheduled during the first and third quarters to enable all parents to meet with their child's teachers. In addition, parents are encouraged to communicate with their child's teacher(s) whenever they have questions or concerns via ParentSquare.

## **Quarterly Recognition Programs**

We celebrate students who have demonstrated outstanding academic achievement and exemplary citizenship skills every quarter. In addition, classroom teachers will have informal classroom celebrations recognizing students in their classrooms and will receive a certificate or certificates for their accomplishments each quarter.

**MAP Honors**: Students in grades 2 through 5 will be recognized during the Winter and Spring administrations for meeting their expected MAP Growth goals in reading and math.

**Citizenship Award:** Students in kindergarten through fifth grade are named on the quarterly Citizenship Honor Roll when the following criteria have been achieved:

• **Kindergarten:** The student consistently respects the feelings, rights, and property of others; follows classroom rules; plays and works cooperatively with classmates; and expresses their feelings in appropriate ways.

• **Grades 1 -5:** Students must have 4s on Work/Social Skills 1 & 2 – Meets school standards for behavior, shows respect for peers, property, and authority

**Super Effort Award:** The Super Effort Award is given each quarter to up to two students from each homeroom that exhibit extraordinary effort or have shown considerable improvement in academics and behavior.

**Samuel W. Tucker Award:** Annually, at the end of the 4<sup>th</sup> quarter, we award one student per homeroom the coveted Samuel W. Tucker Award. An engraved plaque is awarded when the following criteria are met:

#### Visiting the School
