On January 13, 2020, Governor Phil Murphy signed into law A4710, the **Strengthening Gifted and Talented Education Act**.

Pursuant to 18A:7A-11, each school district shall file with the NJDOE Gifted Education Coordinator a report that must contain:

- The gifted and talented continuum of services, policies, and procedures implemented in the school district.
- The professional development opportunities provided for teachers, educational services staff, and school leaders about gifted and talented students, their needs, and educational development.

Program Goals and Objectives

All students enrolled in the Shrewsbury Borough School District are evaluated for the Gifted and Talented Program annually. All curriculum has been developed with differentiation strategies to enrich all grade level content areas for all students enrolled in the Shrewsbury Borough School District. All curriculum can be viewed publicly through the Shrewsbury Borough School District website. All students will be supported to reflect their abilities, potential, and recognize the impact they have on the world around them through the learning process.

Students who are identified for additional enrichment learning through our Gifted and Talented Program will engage in learning activities to support unique interests and abilities and foster a belonging to society(ies) to assist them in reaching their potential. Students will receive this additional enrichment in addition to their scheduled programming during periods dedicated for personalized learning.

Program Goals and Objectives (cont.)

The primary goal of the Shrewsbury Borough School District's Gifted and Talented program is to provide a comprehensive, high-quality educational program that fosters:

- Problem solving through design thinking, reflection, empathy, and resilience
- A sense of accountability, respect, and responsibility as a global citizen
- Developing and understanding a sense of oneself, unique interests, and abilities that cultivates a feeling of belonging to a society(ies) to reach their maximum potential(s)

CogAT Composite Score of 120-124

12 out of 15 possible points on a combination of iReady Math, iReady ELA ,and Fountas

& Pinnell data

Procedures for Ongoing Identification

Eligibility Requirements Continued

Grades Three through Eighth

Path One

CogAT Composite Score of 125 or more

16 out of 20 possible points on a combination of iReady Math, iReady ELA,

NJSLA Math, and NJSLA ELA

Path Two

CogAT Composite Score of 120-124 or more

18 out of 20 possible points on a combination of iReady Math, iReady ELA,

NJSLA Math, and NJSLA ELA

Procedures for Ongoing Identification (cont.)

Maintaining Eligibility

- Students identified as gifted and talented will be reviewed annually for the continuation of the enrichment program
- The program will be revised as required to meet the student's needs, interests, and talents
- Students who show a decrease in metrics will conference with Gifted and Talented Coordinator, Supervisor of Curriculum and Instruction, and Parent with feedback from content area instructors to discuss circumstances prior to the following year

Exiting the Program

A student may be withdrawn from the program when:

- Academic records indicate a decline in performance
- Student wishes to be withdrawn with parent/guardian consent
- Parent/guardian requests withdrawal
- A decision has been made by the parent/legal guardian, teacher, educational services staff, supervisor, with the approval of the Chief School Administrator

Students identified for our gifted and talented program will receive pull-out enrichment twice in a six-day cycle for project-based, enrichment learning. Additional activities may include (but not limited to) academic competitions, guest speakers, and lessons with a specialist.

Parental Appeal

- The Shrewsbury Borough School District's Gifted and Talented Pupils Policy states that, "An individual who believes that the district has not complied with the provisions of N.J.S.A. 18A:35-34 et seq. may file a complaint with the Board of Education. This policy for filing a complaint shall be linked to the homepage of the Board's Internet website. The Board shall issue a decision, in writing, to affirm, reject, or modify the district's action in the matter. The individual may then file a petition of appeal of the Board's written decision to the Commissioner of Education through the Office of Controversies and Disputes in accordance with N.J.S.A. 18A:6-9 and the procedures set forth in State Board of Education regulations."

Parental Appeal (cont.)

If a parent/guardian believes that a student is performing well above grade level or is demonstrating exceptional characteristics or talents, they can write an appeal letter. The letter should include reasoning as to why the parent feels their child should be identified in the program.
