For our first submission, we put in for replacing our aging intra-building fiber to better support building/district-wide wireless deployment. This plan was accepted and we are currently constructing a bid for the project work.

For our first supplemental submission, we submitted to replace all the switches in our MDF closets; to take advantage of the new fiber and higher speeds.

For this supplemental submission, we will be adding additional wireless controllers and access points to areas in each building where 1:1 students will be.

There is a direct linkage between Middle Country CSD's District Instructional Technology Plan and this proposed project. We have completed our

initial district-wide wireless access point rollout. In order to support the increased bandwidth needs of the 1:1 program, bandwidth will be increased on intra-building connections between data closets. Once our new MDF switches (second submission) are connected with the fiber that we install from our first submission, we will be doing just that.

At the conclusion of the 2016-17 school year, the Middle Country Central School District already had full wireless coverage in all 14 instructional

buildings. With the increased connectivity speeds between our buildings and the increased speed to be realized in our buildings after this project, Middle Country will be in a good position to support student and staff access to to the Internet. The wireless controllers and access points that are part of this submission will increase the access point density in areas where the 1:1 program will live.
