- Between 7/18 and 9/5, NYSED unsubmitted plans 2, 3, and 4. The main reason behind the un-submissions was to change the calculation criteria for non-public schools in district.
- Between 7/18 and 9/5, we worked with NYSED Facilities Planning to receive updated project number information they now required for the re-submissions.
- On 7/25, I asked the NYSED Smart Schools office if it would make sense to combine the three plans into one now. Twenty minutes later, I was told that it wasn't necessary.
- Between 9/5 and 9/21, we worked with two representatives from NYSED Smart Schools office making corrections to meet new criteria.
- On 9/20, we uncovered an error in the math for non-public schools in NYSED's updated system.
- On 9/24 we were provided with instructions on combining our plans together into one.
- On 9/26 we submitted the plan (with questions) for their pre-approval as per their instructions and have not heard from them since.
- I emailed them again on 10/21 and 10/31 without a response.
