QUALIFICATIONS:

- 2. Mechanical ability in the repair and maintenance of lawn and equipment.
- 3. Farm experience or horticulture training and landscaping work would be beneficial.
- 4. Must be organized, personable, cooperative, and responsive to the needs of the school district.
- 5. Must be able to lift and carry a 75 pounds infrequently and 35 pounds frequently.
- 6. Possess a valid Louisiana driver's license.
- 7. Must pass physical examination, criminal background check and drug screen.

EVALUATION: PERFORMANCE RESPONSIBILITIES:

- 1. Responsible for the exterior appearance of school district buildings: keep grass cut, cultivate trees, shrubs, and flowers.

- 3. Perform duties in a safe manner to insure the prevention of injuries.
- 4. Maintain inventory of materials, tools, and supplies.
- 5. Perform such tasks and assume additional responsibilities as the district maintenance foreman, Superintendent or designee may assign.

QUALIFICATIONS: The Maintenance Grade 3 Grass Cutter/Painter must be able to perform each essential duty satisfactorily. The requirements described herein are representative of the knowledge, skill, and/or ability essential to job performance. While performing duties, the Maintenance Grade 3 Grass Cutter/Painter is frequently required to stand, walk, speak, hear, and sometimes sit. The Maintenance Grade 3 Grass Cutter/Painter may occasionally push or lift up to 75 lbs., such as boxes of materials. The Maintenance Grade 3 Grass Cutter/Painter is frequently exposed to a work environment noise level, which is moderate to loud. The Maintenance Grade 3 Grass Cutter/Painter must have sufficient visual acuity to be able to work with computer monitor, print texts, and handwritten documents.
