

**Rabun County High School**  
**STUDENT PARKING PERMIT APPLICATION**

The Rabun County Board of Education provides transportation services for all students. Parking at Rabun County High School is a **PRIVILEGE** and for the safety of all students and their property the following regulations are to be observed.

- A. **All student vehicles on campus must register within the first week of the school year or within 3 days of entering school during the year.** Students attaining 16 years of age during the school year should register vehicles prior to bringing vehicles on campus. Any vehicle change must be authorized by RCHS Security prior to parking on campus.
- B. **Students must exit vehicles immediately upon arrival on campus and shall not return to vehicles until leaving campus for the day.**
- C. **STUDENT MUST CLEAR ALL OUTSTANDING SCHOOL DEBT, SHOW PROOF of LICENSE, REGISTRATION, AND INSURANCE to REGISTER FOR PARKING ON CAMPUS.** RCHS is not responsible for the vehicle or contents within the vehicle.
- D. **No student shall have any form of weapon, stolen property, or other contraband, drugs, alcohol, or any substance illegal to minors in his/her vehicle.** All items found in a vehicle are the responsibility of the owner.
- E. **Student vehicles parked on campus are subject to search by school officials at any time and without notice.** The parking lot is periodically checked by drug detecting canines.
- F. **A student is required to park in their assigned space after the vehicle is registered with the office.** No student may use another student’s parking space or switch parking spaces unless approved by the administration. Students with vehicles improperly parked will be subject to fines, loss of driving privileges or towing at owners’ expense.
- G. **All students who buy parking passes will be eligible for a random drug test to be administered at the High School at designated times.** Students selected will not be notified until the day and time of their test. Students selected for the test may not check out until the test is administered, and a positive test could result in the loss of driving privileges.
- H. **Students are to drive in a responsible and safe manner when entering the campus, driving in the parking lot, and leaving in the afternoon.** Anyone who displays unsafe or reckless driving habits and endangers other people’s lives will not be allowed to drive on campus and will be disciplined accordingly.
- I. **Failure to comply with any of the above rules will result in disciplinary action as covered in the RCHS student handbook and Suspensions as listed below.**

- 1<sup>st</sup> Offense: Warning & 1 Week Lunch Detention
- 2<sup>nd</sup> Offense: 1 Week Parking Privilege Suspension.
- 3<sup>rd</sup> Offense: 9 Week Parking Privilege Suspension.

**CAMPUS SPEED LIMIT IS 10 MPH!**

**PERMIT DECAL must be VISIBLE and DISPLAYED on the OUTSIDE of the REAR WINDOW – DRIVERS SIDE**  
**Failure to display your parking pass will result in disciplinary consequences. Replacement stickers are available for \$5.**
