My Future-My Choice Notification Letter

Dear Parents/Guardians of Lincoln Middle School 6th Grade PE/Health students:

In order to meet Oregon's health education requirements, Lincoln Middle School will be delivering the *My Future-My Choice* curriculum (lessons 1-3) during the final week of the Explore/Health rotation (March 11-13).

To clarify, 6th grade Explore classes are taught on a 6-week rotation. This means your student will receive their Health lessons (including My Future My Choice) only while enrolled in Explore/HEALTH. Before teaching My Future My Choice, your student will receive a hard copy of this letter to take home. We'll include a link to this letter in the Lincoln Log (our school's online newsletter) and will also send a copy to the email address you have on file at LMS.

My Future-My Choice is a skills-based, comprehensive, age-appropriate, and medically accurate sexual health education program. It was created to help middle school students recognize the pressures and consequences of early sexual involvement. It also encourages students to make healthy choices for themselves. Students learn about puberty, healthy relationships, assertive communication, healthy decision-making, and consent.

We receive the most questions and concerns about the "Who Am I?" lesson. This lesson provides information about different terms and what they mean, reviews what intersex is, and encourages respect for all people regardless of their identity. We do not encourage students to choose an identity.

We only use the curriculum provided by My Future, My Choice. This curriculum is South Lane School District Board and Administration approved. We stay on script, and only use the video clips listed in this <u>link</u>.

The Oregon Health Education Standards (revised December 2016) and House Bill 2509 requires that age-appropriate, comprehensive sexual health education be taught once a year in middle school.
