

Cupertino Union School District Grounds Department Annual Pesticide

Notification

2024 - 2025

Assembly Bill 2260 (Healthy School Act of 2000) requires school districts to notify all parents and staff annually of the names of all pesticides and herbicides that are planned for use during the school year at all school sites. Cupertino Union School District has established an integrated pest management approach, which means the District uses the least toxic method first and then will work up to stronger chemicals only if needed.

The following pesticides have been identified for possible use during the 2024–2025 school year. Only staff or contractors who have received appropriate application and safety training use these products. Applications will occur during school vacations and staff learning days.
