

**RESOLUTION OF THE BOARD OF EDUCATION  
OF  
DOUGLAS COUNTY SCHOOL DISTRICT RE-1**

(Approving Global Village Academy Expansion of  
Grades Served and Authorizing First Amendment to Charter Contract Reflecting Same)

WHEREAS, on June 18, 2013, pursuant to the Charter Schools Act, C.R.S. §§ 22-30.5-101 to 120 (the “Act”), the Board of Education (“Board”) of Douglas County School District (the “District”) approved the original application and granted a charter to Global Village Academy – Douglas County (“School”); and

WHEREAS, the original charter granted to Global Village Academy authorized and approved the School to serve students in grades K-8; and

WHEREAS, on or before September 1, 2019, the School submitted to the Board a charter school renewal application seeking renewal of its charter for a term commencing on July 1, 2020, and ending on June 30, 2025 (the “Renewal Application”) and also requesting that it be authorized to serve students in grades K-5 during the renewal term; and

WHEREAS, on January 21, 2020, the Board approved the Renewal Application in the best interests of the District, its students, and the community and renewed the School for a five-year-term; and

WHEREAS, the present Charter Contract between the District and the School, effective July 1, 2020 through June 30, 2025, authorizes the School to serve students in grades K-5; and

WHEREAS, on or about a date between March 1 - 15, 2023, the District’s Choice Programming Office received an expansion application from School requesting that the School expand to serve students in grades K-6 without the need to make physical improvements to the existing building; and

WHEREAS, the District’s Charter School Procedures Manual provides that for existing district charter schools interested in expanding grade levels, the following criteria must be met:

- The school must have been in operation for at least three years;
- The school must have a proven program demonstrating compliance with district and contract standards in the areas of academics, finance, operations and governance; and
- There is demonstrated demand for the expansion.

WHEREAS, the School has met the criteria to support its request to expand to serve students in grades K-6 as the District's Choice Programming Office has determined that:

- School has been in operation for at least three years;
- School has a proven program demonstrating compliance with District and contract standards in the areas of academics, finance, operations and governance; and
- There is demonstrated demand for School's expansion to serve students in grades K-6.

WHEREAS, District staff recommends that School be allowed to expand to serve students in grades K-6 through the remainder of the present Global Village Charter Contract term.

NOW THEREFORE, BE IT RESOLVED by the Board as follows:

1. That approval of the expansion request authorizing School to serve students in grades K-6 through June 30, 2025 is in the best interests of the District, its students, and the community.

2. That the School's expansion request is hereby granted and School shall be allowed to serve students in grades K-6 through June 30, 2025.

3. That the District enter into a First Amendment to Global Village Academy Charter Contract substantially in the form of the document attached hereto as Attachment A.

3. The Board hereby authorizes the Board President, the Superintendent of Schools, or their respective designees to execute such First Amendment to Global Village Academy Charter Contract.


