Data Story Name: K-12 Math

Initial Data Analysis: Grades K-6:

Based on the data review, our main challenge (in the subject of mathematics) is that when students are in third and fourth grades, their proficiency begins to decline and continues to



decline in each grade level thereafter. This is shown in both iReady and M-Step data. The percentage of students who are proficient decreases each year.

Another main area of concern was the proficiency of economically disadvantaged students. Approximately half of the students who are economically disadvantaged are considered to be Tier 3 on the iReady assessment.

Grades 7-12:

Proficiency levels on PSAT/SAT declines after 9th grade (between Algebra I and Geometry). Scores remain consistent (below state average) after 10th grade (between Geometry and Algebra II). Passport to Advanced Math is the lowest scoring domain in addition to Heart of Algebra. Junior high math scores on the i-Ready diagnostic remain consistent. However, not all cohort groups (7th grade) are increasing proficiency. In regards to i-Ready diagnostic data, there is a difference in performance levels for students who are economically disadvantaged as compared to their peers. In addition, students of color are scoring below their peers on the i-Ready math diagnostic. There was no significant difference between the scores of males and females on the i-Ready diagnostic.

## Initial Initiative Inventory and Analysis: Grades K-6:

We are currently researching a new math curriculum for grades K-5 (Bridges). This would allow for consistency throughout grade levels in terms of vocabulary, strategies, and instructional style. It would also improve our ability to track the growth of cohorts of students throughout grades K-5. This curriculum also provides an intervention component that could help assist students that are struggling with gaps in their math understanding. We have also discussed the possibility of having more teachers trained in Advantage Math Recovery.

Another initiative would be the academic enrichment / intervention which could include Title One, tutoring, a study skills time for at-risk students, iReady summer learning program, collaborative data analysis (including grade level meetings, school improvement meetings, MTSS data review team), and summer school.

### Grades 7-12:

Academic math intervention, SAT prep camps, PSAT/SAT data analysis, changes in instructional/assessment practices based on data analysis, curriculum alignment based on data analysis are the initiatives for the Jr./Sr. High School.

## Gap Analysis: Grade K-6:

Currently, our students are not showing the desired progression of proficiency in math. According to iReady data, the current fourth grade students show that 15% are two or more grade levels below. These same students have gone from 0% to 0% to 10% to 15% (of students who are two or more grade levels below) over the past four school years. On average, over the past four school years, Kindergarten students have 0% that are two or more grade levels below. First grade students are 1%. Second grade students average 3.25%. Third grade students average 4.75%. Fourth grade students average 8.25%. Fifth grade students average 7.75%, and sixth grade students average 12%. Ideally, we would want our students to show continued growth on iReady and M-Step from each year to the next.

## District Data Story Summary: Grades K-6:

All students are underperforming district expectations in mathematics overall as a building. The proficiency tends to decrease beginning in grade three and continues to decline each year. There are significant gaps with students who are considered economically disadvantaged.

We are currently researching a new math curriculum for grades K-5 (Bridges). This would allow for consistency throughout grade levels in terms of vocabulary, strategies, and instructional style. It would also improve our ability to track the growth of cohorts of students throughout grades K-5. This curriculum also provides an intervention component that could help assist students that are struggling with gaps in their math understanding. We have also discussed the possibility of having more teachers trained in Advantage Math Recovery.

Another initiative would be the academic enrichment/intervention which could include Title One, tutoring, a study skills time for at-risk students, iReady summer learning program, collaborative data analysis (including grade level meetings, school improvement meetings, MTSS data review team), and summer school.

We also do not currently have a program or service focused specifically to help students who are economically disadvantaged.

Economically disadvantaged learners at the greatest risk are not currently receiving prevention programs.


Any student who are third grade and higher are not receiving intervention services in the area of mathematics unless they are identified as an IEP student.

Data Story Name: Developing Instructional Practices to Increase Student Achievement

Initial Data Analysis: After evaluating our data resources, we recognize as a district that there are areas of improvement. Specifically, we are focused on instruction that needs to be defined and clearly communicated with staff. Given our goal to improve student achievement data across the DK-12 grade levels, we will provide proper support to our staff.

In DK-12, we are seeing an increase in social-emotional needs for our students. Based on the student achievement data, fluctuation with attendance due to Covid, and home environment challenges, there has been an increase in need for support for SEL.

Initial Initiative Inventory and Analysis: The data has provided us a roadmap to defining our areas of growth and achievement in math, ELA, social/emotional through the lens of our instructional practices to in help increase the whole learner, including student growth and achievement.

Furthermore, provide more support and opportunities for SEL for our students and families grades DK-12. Additionally, PTO and the district is trying to bridge the gap between home and school. Also, look at fidelity of interventions being implemented or provided to at-risk students and determine if/what changes need to be made to provide support early on in their academic career.

revamping our current area of need for instructional practices is updating and revamping our current instructional/curriculum needs. District Data Story Summary: After evaluating our data resources, we recognize as a district that there are areas of improvement. Specifically, we are focused on instruction that needs to be defined and clearly communicated with staff. Given our goal to improve student achievement data across the DK-12 grade levels, we will provide proper support to our staff.

The data has provided us a roadmap to defining our areas of growth and achievement. Our main focus is driving more up to date Tier 1 instruction in the classroom by providing opportunities for internal/external professional development with a goal of accelerated learning mindset.

As a district whole, we are providing access to services for all of DK-12 learners in identified areas of student challenge, specifically in reading and math. In targeted grade levels of K-4. Implementation of our pre-k and GSRP full-day program has provided access to early learners. At the jr. high level, an at-risk intervention group is being implemented. Our current area of need for instructional practices is updating and revamping our current instructional/curriculum needs. Our goal is to provide those supports to have credentialed staff feel more confident in tier 1, 2, 3 instructional practices along with identifying those students more efficiently and in a timely manner.

We have uncovered strengths within student attendance, iReady, and Powerschool Log Entries in reference to our social-emotional learning. Challenges that we are facing consist of Covid-19 hesitances, virtual learning with inconsistencies between in-person and virtual, home-environment challenges, family involvement, mental health, and behavior/discipline. As a result of these challenges, we are seeing that a percentage of our economically disadvantaged population is 2-3 grade levels behind in both math and reading. Additional data that we may need includes: request for team meetings to determine if SE referrals are necessary or if there are alternative Tier 2 and 3 Interventions to be tried. Implementation of at-risk hours for study hall for students at the Jr/Sr High level to encourage success and a goal to align benchmark assessments so teachers have more focused data to target individual students for added support.

In DK-12, we are seeing an increase in social-emotional needs for our students. Based on the student achievement data, fluctuation with attendance due to Covid, and home environment challenges, there has been an increase in need for support for SEL. Implications that have been identified are the need to provide more support and opportunities for SEL for our students and families grades DK-12 with a goal to bridge the gap between home and school. Additionally, we will look at fidelity of interventions being implemented or provided to at-risk students and determine if/what changes need to be made to provide support early on in their academic career.

We recognize that all students and staff, including community families, is facing Covid challenges, what we hope to provide as a district is a stable learning environment with opportunities for students to gain access to SEL support which in turn will hopefully lead to higher academic success, both individual and group.
