Amanda Smith

Amanda Smith was a member of the Seneca Valley swim club since age 5. Some of her High School swimming accomplishments are 3 Time State Champion, as well as a State Record holder in the 200 IM. Along with the State Record she was the Penn State University Pool record holder in the 200 IM. Amanda was MVP of the Women's Pennsylvania State Championship Meet in 2001. She held the WPIAL record in the 200 IM as well as a 5 time WPIAL Champion. Amanda was a fourteen time Swimming All State, and a ten time Swimming All American. Amanda was also the team captain of the Seneca Valley WPIAL team runner up in 2002. During her high school career she was a 3 time Junior National Champion as well as a Junior National Record Holder. As a sophomore in High School, Amanda also qualified for the 2000 US Olympic Trials.

Amanda obtained a scholarship and went on to swim at University of North Carolina Chapel Hill. While swimming at UNC she obtained multiple all ACC Honors as well as held a UNC School Record and ACC record in the 800 freestyle relay. She was also all time Top Ten in the 200 Free, 500 Free and 400 IM at

She was a member of the coaching staff for the Seneca Valley men and women's varsity swim team from 2007 to 2010 and is currently the Head Coach for the Seneca Valley Swim Club.




Thomas Heckendorn

Thomas Heckendorn was appointed to the position of Head Football Coach for the South West Butler County School District in 1964. Mr. Heckendorn was selected to be the first head coach of the newly formed district that would become The Seneca Valley School District. Coach Heckendorn was given the task of merging two rival teams, Evans City High School and Zelienople High School, into a single team that would have to compete at a much higher level of competition than either institution had previously seen before.

During the 1964 and 1965 seasons the new team struggled on the field against several 4A opponents. The team became more competitive in it's third season when coach introduced a new offense and the schedule realignment brought the new district into a more appropriate schedule.

Coach was the father of the program and quickly saw a need for the program to expand. By the third year of his tenure as the Head Coach the program grew to include students from grades 7 through 12. Coach's vision for the program's expansion also included building a youth program to feed the Middle School teams. With the help of Mr. Bill Binder and Mr. Bill Imman he developed a youth football program for the 6th grade students as well. From this point coach had ensured that all of the necessary steps were taken for the Seneca Valley Football Program to grow.



Dennis Stewart

Denny Stewart is a life long resident of Harmony Pennsylvania. Denny Stewart's life and career reflect a love for and dedication to sports as well as the Seneca Valley community. Denny is a graduate of the First Seneca Valley Class to spend four years of high school together after the consolidation of Evans City High School and Zelienople High School.
