Harrison Township School District will be offering a Summer Literacy Program for students entering 4th grade. This program will help and encourage your child's growth in the area of English Language Arts (reading, writing, and spelling/word study). This letter is to notify you that your child has been selected to participate in this program which is supported by No Child Left Behind Title I funds.

There is no cost to parents for these sessions; however, parents will be responsible for providing transportation for their child.

The program will be held for 5 weeks on the following dates:

- Monday, July 7th and Wednesday, July 9th
- Monday, July 14th and Wednesday, July 16th
- Monday, July 21st and Wednesday, July 23rd
- Monday, July 28th and Wednesday, July 30th
- Monday, August 4th and Wednesday, August 6th

Each tutorial session will run for approximately one hour and fifteen minutes. During the session, your child will be working in a small group with Mrs. Bottone and Mrs. Sanders. The student-to-teacher ratio for this summer program will be approximately 5 to 1.

Your child will be attending the session from «ESY_ELA2». Please bring your child to the Harrison Township School Main Office and a teacher will meet you at the door and take your child to the classroom. At the end of the session, a teacher will bring your child to the Main Office where you may pick them up.

In addition to these services, your child has been identified as a student who would benefit from being assigned to a classroom where additional support is available through our ELA Intervention Program (Basic Skills) for the 2014-2015 school year. This identification was based on longitudinal test data (MAP, DIBELs, and/or NJASK) and second trimester reading levels from the 2013-2014 school year.

By having additional staff (ELA Interventionist and/or Instructional Aide) assigned to your child's classroom during instructional reading time, student-teacher contact time is increased. In addition, the staff has the ability to provide intensive and direct instruction. Research has demonstrated that small group differentiated instruction is a significant factor in facilitating a student's ability to meet grade level expectations.

Please complete the enclosed form and return it to your child's homeroom teacher by June 25th.
