G. PRESENTATION OF PROPOSED BUDGET FOR 2021-22 SY

- 1. Commissioner Director Robinson questioned if the school will be reopening to full day. SCVTS is currently operating four days per week, full time and is expected to open five days per week in September 2021.
- 2. Commissioner Singleterry asked what the 2% increase represented. It represents the increase in the tax levy. The total budget is only increasing .33%.
- 3. Commissioner Marano asked if the Integrated Technology Systems program will be available in September. The program is currently being revamped to comply with DOE requirements.
- 4. Commissioner Director Robinson asked if high school juniors in the ITS program would be "grandfathered" into the subsequent program. Yes, the two juniors. will be included in the new program or other programs with the exception of the MEAM program, as it is a four year program only open to freshmen.
