Re: Student Services Report

The Student Services update tracks activity for out of district tuitions, preschool enrollment, special education aides, contracted services, and transportation.

Currently, there are 161 students in out of district placements including 34 for whom we have agreements with parents. There are currently 16 pending placements. At the high school level, one student was placed out of the district, and one parent agreement ended when the student returned to the district. At the middle school level, one student was placed out of district. There was no movement at the elementary and pre-school levels. The projection for tuition shows a surplus of \$225,314.

The Newton Early Childhood Program (NECP) currently serves 268 students. There are currently 93 students with special needs enrolled in preschool classrooms, 75 students who are typically developing enrolled in preschool classrooms, and 100 students with special needs receiving related services only.

The forecast for aides projects a total surplus of \$62,658, and the forecast for contracted services projects to be as planned for FY16.

There are a total of 502 students receiving Special Education Transportation. The number of students receiving out of district special education transportation is 125, and the number of students receiving in district special education transportation is 377. The forecast for transportation projects to be under plan for FY16.
