Pre-registration Certification

Students Over Age 18

The following information is for **students over age 18** residing with a Newton family or living independently. Forms must be completed, notarized and returned to the Newton Public Schools, Room 218, 100 Walnut Street, Newton, MA 02460.

In order to attend the Newton Public Schools, a student must actually reside in the City of Newton. In determining residency, Newton Public Schools reserves the right to request a variety of documentation and to conduct an investigation into where a student actually resides. Those students who cannot provide requested proof of residency will be referred for a residency check by the Newton Police Department, Community Services Bureau. Because residency can, and does, change for students during the course of the academic year, we may continue to verify residency after the commencement of classes and we may act upon anonymous tips received to conduct a residency verification investigation.

It is also the responsibility of the student to notify school personnel immediately if a change in residency occurs. In addition to student information, we also require information from the owner of the property and the resident(s) in shared tenancy where a student currently resides.

Students found to be in violation of the residency guidelines will face strict penalties, including, but not limited to, immediate dismissal from school; per diem fines for the education and related services accessed as a non-resident which are based on the per pupil cost to the district and, possible legal action.

Directions:

- 1. **Student Over Age 18 Pre-registration Certification Form** the student must complete all information and have the form notarized.
- 2. Shared Tenancy for Students Over Age 18 Form If the student is residing with a tenant and not the property owner, the person whose name is on the lease agreement must complete all information and have the form notarized.
- 3. **Property Owner Pre-registration Certification Form** The owner of the property must complete all information and have the form notarized.

All forms must be returned to Newton Public Schools, 100 Walnut Street, Room 218, Newton, MA 02460.
