## **Focus Groups**

  - We need a moderator and note-taker for each Focus Group. (there are 7 of us);
  - We will ask permission to audio-record the Focus Group sessions; it might be hard to capture everything, note-taker will lend bias to what is recorded, having an audio recording will be a truer and more thorough record of the conversation.

4 What do you view as the advantages and disadvantages of each elementary school contributing to a central pool that will pay for curriculum-related items that fall under the equity cap?

5 What do you view as the advantages and disadvantages of each elementary school contributing to a central pool that will pay for allowed technology spending?

(Note to moderator: In answering question 5, make sure this question gets addressed: How do you think your fundraising ability would be affected if some portion of the funds you raised were shared by elementary schools throughout the city?)
