Re: April 2024 Treasurer's Report

Attached are financial reports for April 2024. Below are explanations of major variances compared to the prior year.

Local revenue is approximately \$8,872,000 greater than prior year, primarily due to an increase of approximately \$5,572,000 in real estate tax revenue. This increase reflects the impact of a 4.1% tax rate increase and assessed value growth compared to the prior year. Interest on investments is approximately \$2,843,000 greater than prior year due to increases in interest rates. Earned income tax revenue and other tuition revenues are in excess of prior year by approximately \$723,000 and \$108,000, respectively. Local Service Tax revenue is \$113,000 greater than the prior year due to the timing of receipts. Real estate transfer tax revenue is approximately \$564,000 less than the prior year.

State revenue is approximately \$2,391,000 greater than the prior year. Basic education subsidy, retirement, and social security revenues are greater than prior year by approximately \$1,417,000, \$438,000, \$118,000, respectively. Rental/sinking fund payments are greater than the prior year by \$168,000 due to the timing of receipts. Federal revenue is approximately \$867,000 less than prior year due to spending down the ESSER funds and timing of title grant funds.

Expenses are in excess of prior year by approximately \$8,330,000. Personnel expenses are excess of the prior year by approximately \$4,843,000. Salaries increased approximately \$3,893,000 and benefits increased approximately \$950,000. Non-personnel related expenses are greater than the prior year by approximately \$3,487,000, most notably due to the timing of technology related expenses, increased contracted carrier costs, and the impact of the implementation of the new elementary reading curriculum program.

On a monthly basis, actual revenue and expense by detailed lines are compared to budget and prior year actuals. The budget column represents the full year, therefore, each month we look at the receipts or spending to date as a percentage of the total budget, taking into consideration known variations in the timing of each line.
