CRITERIA FOR RECOMMENDING A NON PAID COACH

- 1. A sport with four or more approved, paid coaching positions may not exceed a total of two non-paid coaches, other than student teachers or interns.
- 2. A sport with three or less approved, paid coaching positions may not exceed a total of one non paid coach.
- 3. In addition, the following guidelines must be observed for the non paid coach:
 - is a high school graduate.
 - has demonstrated experience in the sport as a participant or coach/or sufficient training as a coach (coaching minor or concentration or the equivalent).
 - is under the direct supervision of a paid, certified teacher/coach and is directly responsible to the head coach in regard to techniques, philosophy, practice schedules, and drills.
 - The building principal or athletic director, with input from the head coach, will evaluate the non-paid coach's effectiveness and if performance is unsatisfactory will make a final recommendation in cooperation with the district athletics/activities department concerning dismissal.
