1. **Will all bids be opened at 1pm or 2pm on 8/2? On page 1 it states that the offers must be submitted by 1pm. On page 2 it states that all bids should be received by no later than 2:00pm.**

2. **Can you ensure/clarify that the liners provided by the school district will be BPI certified as this is what is accepted at the Bees Ferry Compost facility?**

**Whatever liners are required by the landfill is what will be used**

3. **Responsibility for contamination was not mentioned in the Invitation For Bid. Who will be responsible for excessive contamination if it were to occur? Could you include a more specific description of how the vendor should address heavy contamination if it occurs during the contract period?**

**Heavily contaminated containers should be evaluated by the hauler at the time of pick up and if found to be heavily contaminated the containers should be left for the district to dispose of. The vendor must notify the district when this occurs by either phone or email, or both. This notification would be to the district designee.**

4. **Please further explain the “no landfill fees” statement on page 23. Does this mean that the vendor would not pay tipping fees at McGill for CCSD waste?**

**As part of this contract you bid pricing must include all and any fees, tipping fees, ect. The district will not accept separate billing for any fees.**

5. Should the fleet size include all vehicles in the vendor's fleet or be the number specifically operating in the Charleston area?

**It should include All the hauling vehicle in the vendors fleet**
