This Addendum is issued prior to the receipt of bids and the intent thereof is to record and insert certain changes, additions, and clarifications of the contract documents. All items shall be considered in connection with the various Contractors' Proposals.

CONTENTS

This Addendum contains the accompanying 2 pages and drawing sheet A0.1.

NO. **DESCRIPTION**

- CLARIFY District standard hand dryers are specified in Specification Division 10D. No alternates will be 01 accepted. Only multi-gang toilet rooms shall have hand dryers.
- CLARIFY Toilet room partitions basis-of-design is specified within Specification Division 10D. 02
- 03 CLARIFY – Each sink fixture type "L-1" (Bradley, MG-2) requires a 110V GFCI power outlet. Refer to sink manufacturer's cut sheet for more information. Utilize existing circuit space on electrical panels shown on drawing sheet E2.0.
- 04 CLARIFY - Room A106a (Health Office) requires floor tile and base as shown on drawing sheet ID200.
- 05 CLARIFY – Toilet rooms shall have all existing toilet room accessories removed (dispensers, mirrors, etc.) as noted on the drawing sheets. Bidders should plan for miscellaneous wall patching and infill. Example: recessed paper towel/garbage dispensers are in existing single occupant toilet rms. Infill wall with matching construction.
- 06 CLARIFY - Referring to drawing sheet ID200, there are no Alternates 1 or 2.
- 07 CLARIFY - Reuse existing sink carriers within individual toilet rooms. New wall mounted sinks (type "L-2"). Existing sink carriers at multi-occupant bathrooms shall be removed & patch walls as needed to accommodate new wall mounted sink type ("L-1").





- OB CLARIFY Sink type "L-2" shall be American Standard 0355 (or approved equal), wall hung, vitreous china, front overflow, 4" centers, self-draining deck, faucet ledge. Contractor to confirm existing wall carrier or hangars accommodate new sink. Provide stainless flex hose supply lines, P-trap drain assembly, and ADA-compliant undersink trap-wrap.
 - a. Provide faucet: Sloan, SF-2350, battery powered sensor faucet, 4" centers, vandal resistant chrome plated brass body, safety timer, 0.5 gpm, provide with ASSE 1070 mixing valve.
- O9 CLARIFY Provide new paint ("EP1" per sheet ID200, general notes) on all exposed gypsum board walls within each toilet room or area of work.
- 10 CLARIFY Multi-occupant bathroom's "wet walls" to receive new wall tile as shown on drawing sheet ID200. No wall tile included within single occupant toilet rooms.
- 11 CLARIFY Provide new paint to both sides of hollow metal door frames.
- 12 CLARIFY Any removed grab bars from toilet rooms shall be replaced in-kind.
- 13 CHANGE New opening frames into Toilet Rooms A107, A152 & A153, B144 & B145 shall be storefront aluminum (color:black). Patch/repair walls as needed at removed door frame locations.
- 14 CHANGE Entry door & hollow metal frame into toilet room B111 shall remain.
- 15 CHANGE New mirrors shall be removed from Specification Division 08C. Instead, Division 10B shall provide. Bradley, 781 Series, Channel Frame Mirror (or approved equal) shall be provided a sized per drawing sheet A3.0.
- ADD Single occupant toilet room A133 shall be added to project scope. Refer to attached drawing sheet A0.1 for reference.
