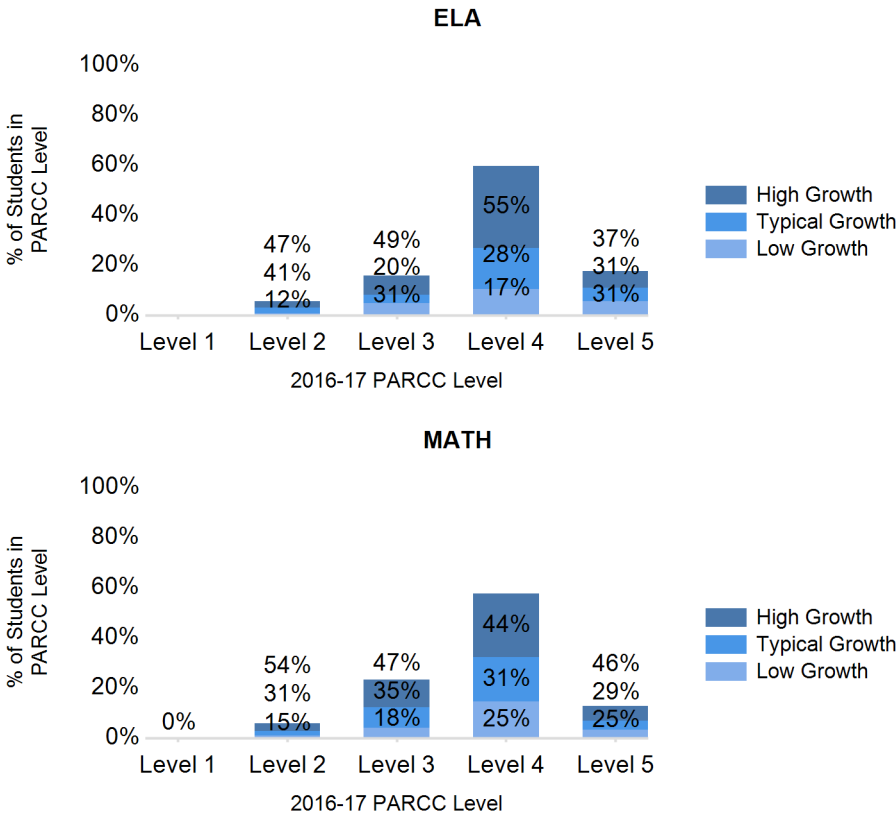

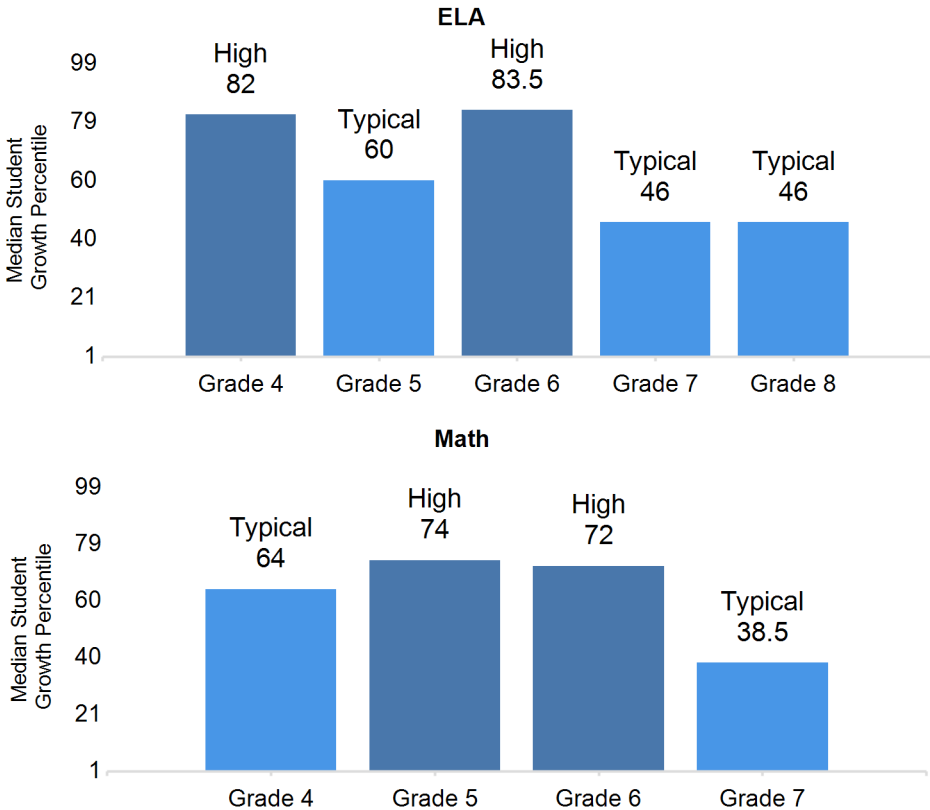
Student Growth by Performance Level

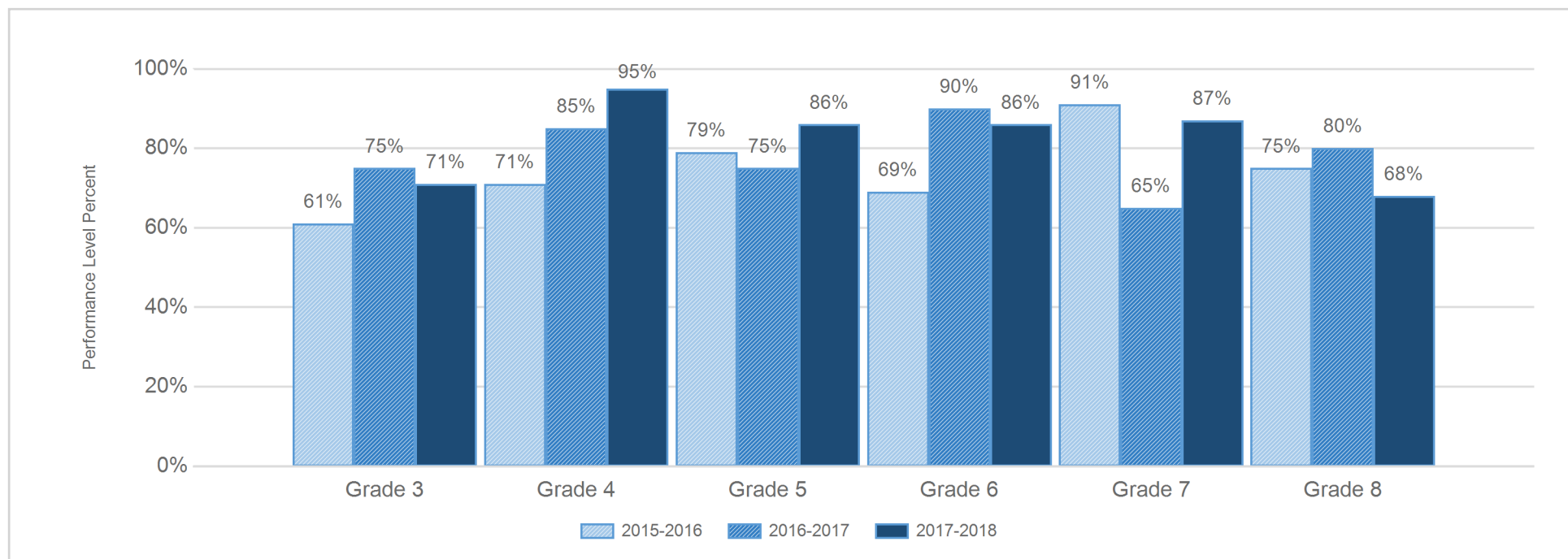

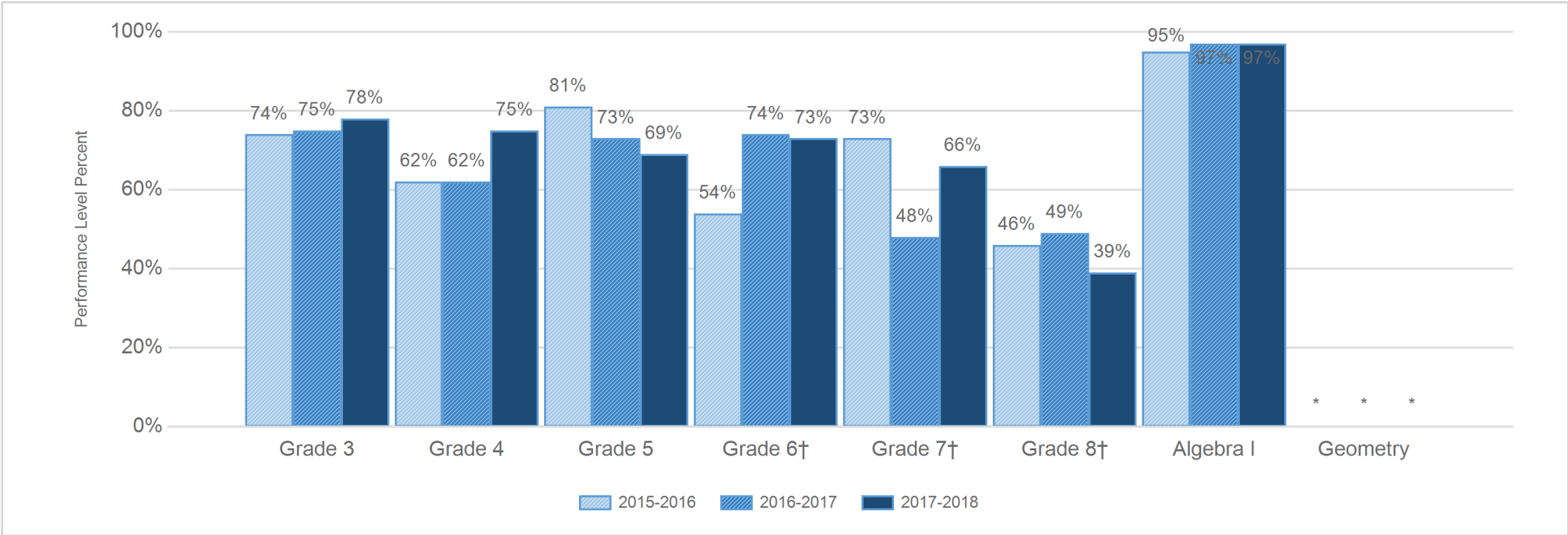

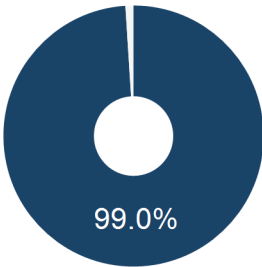

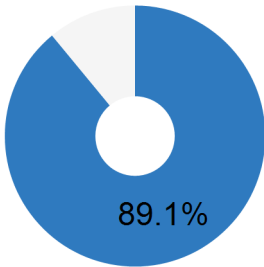

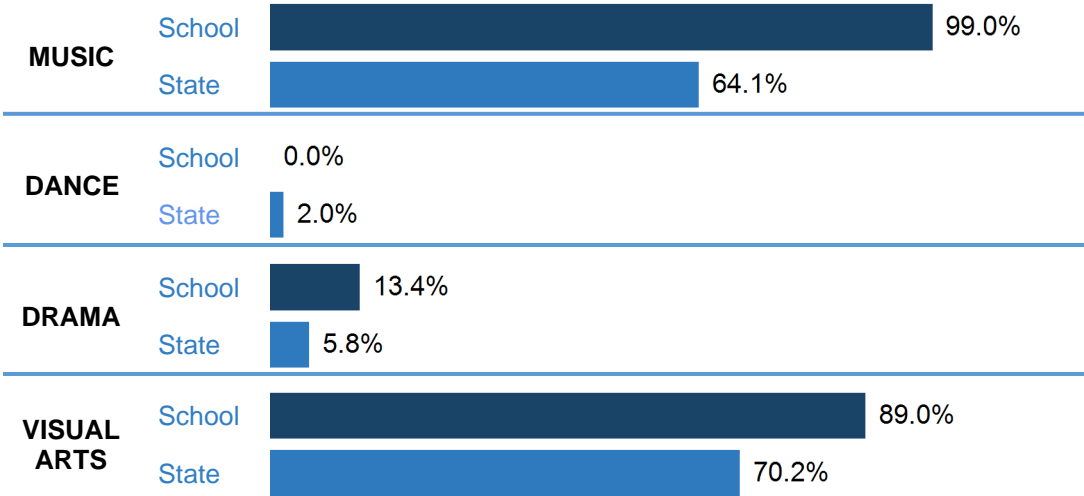

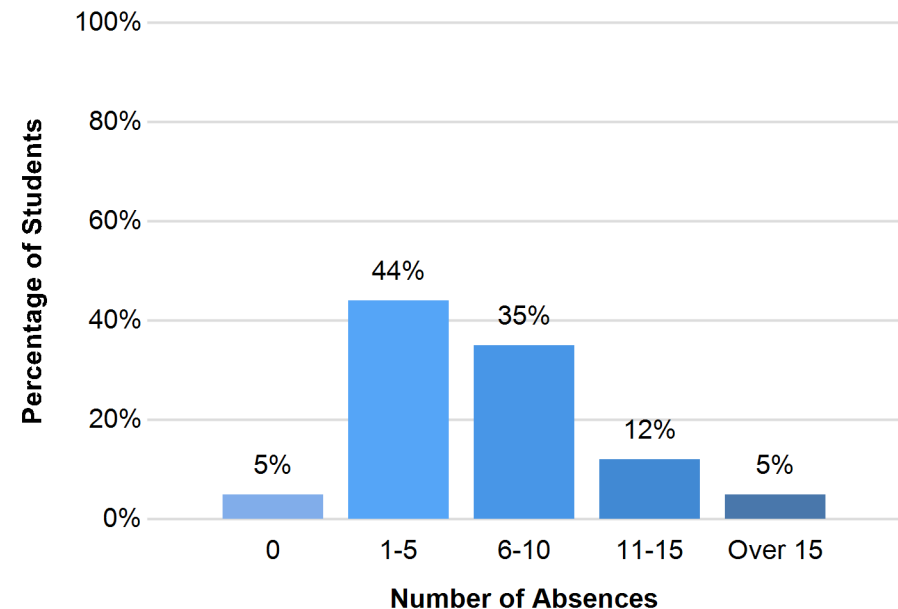

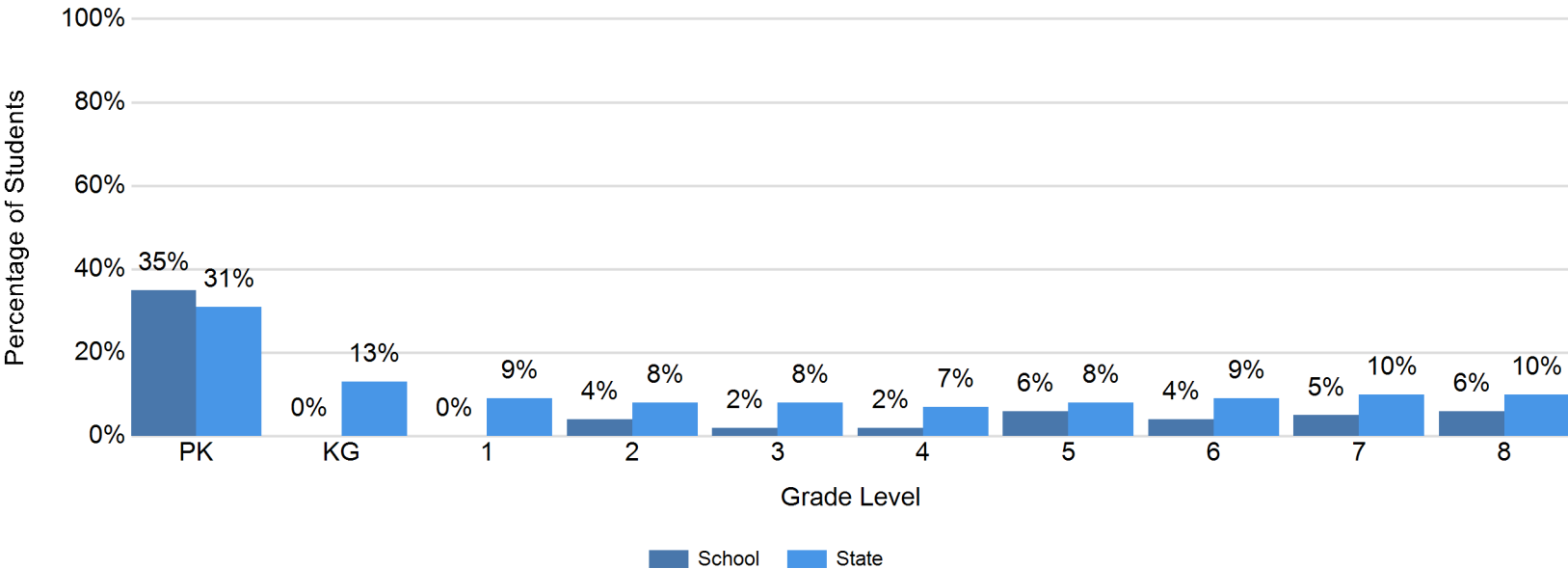

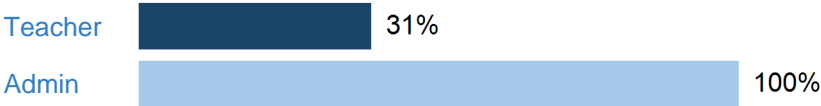

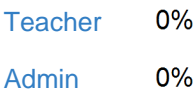

All windows and doors have been newly renovated. For the safety of our staff and students additional security cameras have been installed both internally and externally on the school grounds, and we are in the process of replacing our light fixtures with LED lighting.</div>
<div> <div> </div> <div>School Safety:</div> </div>	<div>The safety of our students and staff is a primary concern. We currently have 34 security cameras located both inside the building and on the grounds outside. In addition, a police officer is stationed on the premises before, during, and after the school day with full access of the property. There is also a 'fob' system installed with three access points to gain entry into the building. These fob's are for staff members only and they are programmed to allow access only at certain times each day. With the exception of the main entrance, external doors are locked at all times, and visitors must be 'buzzed' into the building to gain entry. Critical Response Group presented to board members how they work with local law enforcement in the event of an emergency at the school.</div>
