Renewal

As the charter school authorizer, the School District of Pittsburgh is responsible for the renewal of charter schools, as requested.

Charter agreements are typically for a period of five (5) years.

Renewals consider information gathered from four (4) previous annual reviews.



Causes for Non-Renewal:

- 1. One or more material violations of any of the conditions, standards, or procedures contained in the written charter signed pursuant to section 1720-A
- 2. Failure to meet the requirements for student performance set forth in 22 Pa.Code Ch. 5 (relating to curriculum) or subsequent regulations promulgated to replace 22 Pa. Code Ch. 5 or failure to meet any performance standard set forth in the written charter signed pursuant to section 1716-A*
- 3. Failure to meet generally accepted standards of fiscal management or audit requirements
- 4. Violation of provisions of this article (the Charter School Law)
- 5. Violation of any provision of law from which the charter school has not been exempted, including Federal laws and regulations governing children with disabilities
- The charter has been convicted of fraud.



Review Process

- Annual site visits over term of charter
- Review team reports and discusses findings in terms of renewal criteria
- Findings presented to the Board on June 6, 2023.
- Board votes on June 28, 2023.

Highlights

- The creation of a graduate portrait that describes the ECS community's aspirations for its students. The Graduate Portrait shares trends that students may encounter and the values which are held around environmental literacy. It describes the knowledge, skills, dispositions, and mindsets that ECS's students need to thrive in life and career. The Graduate Portrait guides adult actions and decisions, and aligns leadership, teaching and learning, and resource allocations for students growth from kindergarten through graduation.
- The Bike ECS program where students in 3rd-11th grade learn how to and gain confidence in biking throughout the city
- Supportive school cultures across buildings with both primary and intermediate earning the distinction of being PBIS Banner School awarded for fidelity of practice
- A partnership with the Just Discipline Project to develop the restorative practices approach, K-12
- An enrichment program that is open to all students where the school leans into a variety of strengths, not just core academics; Students access enrichment opportunities like battle of the books, Shakespeare competitions, and book clubs throughout the school day and year



Highlights

- An Education for Sustainability graduate course for teachers launched where cohorts of staff are
 introduced to foundational understandings of sustainability and how to promote a mindset that
 supports sustainability in a K-12 setting; Connections between sustainability, poverty, and equity
 issues are highlighted within the course.
- The creation of a remix lab where students are invited to explore their X factor as they level up their learning in new ways. Here, students have access to an expansive assortment of materials, tools, and technologies for creativity and self expression. Students can explore what remix has to offer through a variety of means: Block Zeros, whole classroom collaboration, curriculum project remiXes, and individual projects. Through tinkering, making, and storytelling, students develop both their creativity and their agency as stewards of the future.
- High School Quest Labs or intercessions: ECHS's Quest Labs are mini-expeditions where students learn by doing and actively engage in a variety of real-world experiences that explore new disciplines and industries outside of their daily school context.
- Robust partnerships, including: Chatham University, Tree Pittsburgh, Venture Outdoors, Union
 Project, Garfield Farms, Assemble, National Opera House, Communitopia, Oasis Farm and Fishery,
 Hip Hop Unlock, and more
