The media of public officials have been missed lead by individuals that they weren't aware of what was the reason for Ms. Hodge's sudden resignation those are your reasons and again I mention I am disappointed by those actions.

Prado,

The action that were taken were in violations of the law in legal terms, Mr. Escamilla if I'm wrong please correct me, I think that's considered gifting of public funds, is that correct and that is a violation of law we could not continue to have this district act with that kind of practice going on and I'm glad to see that Ms. Hodge although she worked for the district for 32 years but she has taken it upon herself to resign at this time and I will be accepting her resignation.

I for one did not want to bring anymore controversy to South San we have more than our share but with the superintendent gifting of public funds I will not sit here and do nothing that was not what I was elected to do, for the last two board meetings, Ms. Prado, Mr. Mata and myself found \$240,000 dollars just sitting there if there is any gifting of monies it should be gifted to our students in the classroom, curriculum is a core of this district educating our students, improving our scores for the past six months a secretary has been running our curriculum department, two PHD's, Doctorate's, applied for this position our Superintendent was content with the secretary running curriculum, this is not the direction we want for South San, South San deserves better and if we have to sit here in front of a firing squad so be it, South San deserves the best.

I'm allowed to speak again, Madam President (Malda: No Roll Call Vote), I find it cowardest that ya'll would sit behind here, place the blame on her when you directed her to do those actions, no I will not accept this resignation it was forced.
