I'm here to clarify some miss information that was in the media recently at the April South San School Board Meeting, South San AFT spoke against participating directly in the Pre-K 4 SA program. South San already has an outstanding Pre-K Program. Why would we participate if its dismally to benefit for Pre-K 4 SA? South San AFT did hope for a collaborative relationship with Pre-K 4 SA, for example the grant for Pre-K Development runs out his school year while Pre-K 4 SA has money that can be used for professional development, but has we discovered in that Board Meeting they do no collaborate except on their terms. This is unfortunate and the antithesis to help public education works. The Superintendent made the correct recommendation not to participate, the School Board took the right position in voting to not to participate and after review even the express news recognized in an editorial that it was the right decision. By your vote you as Trustees took a political risk as you did not know what
Tom Cummins	the political results would be. As South San moves forward, AFT urges you to continue not to look at the political picture but what is good for South San Students. Thank you. Mrs. Madla, Members of the Board, Dr. Saavedra, members of the audience, my name
iom Cummins	is Tom Cummins and I representing the South San AFT. Tonight AFT would like to request that you review over the summer the possibly of a tax reauthorization election. We've spoken to you about that before but from the way things look we don't think the legislature is going to be very supportive of public education and its funding in its

coming session we may get lucky but that's not what state leaders are talking about. The law does provide for district to raise their taxes beyond a \$1.04, if you were to raise it after permission is granted after the tax reauthorization election, you could raise to a \$1.06 and gain substantial amount money preferable cost to the district. Those two pennies are called the golden pennies. Those two pennies would raise \$257, 000,00 from South San residents and businesses but it would gain \$1.2 million from the state for a total of \$1.4 million. So you can see just going those two cents is an important step financial for the district. If you were to raise to the maximum of \$1.17 the increase on the district residents and businesses would be \$1.6 million but your money from the state would be \$4.0 million for a total increase for about \$5.7 million. These figures were estimated by the financial and business offices by the school district last October. Some districts in Bexar County have already had TRE Elections and those include Harlandale, Alamo Heights and Edgewood. So you can see it's not just an issue of local property wealth district or high property wealth districts but all districts and during the summer we hope you review the benefits of these and consider having a tax reauthorization election. Thank you very much. Stacey Estrada Good evening board, Madam President, Connie Prado everybody Dr. Saavedra, hello everybody. First of all, the reason I came today, we always have very important things at our board meeting, especially our children. The intention of board meetings is for our Board Members to be present, so that we can make very important decisions.
