Pete Alaniz	Mr. Longoria, Dr. Saavedra, Members of the School Board; my name is Pete Alaniz representing South San AFT. Tonight I would like to address, pay increases after years of neglect a substantial increase is desperately needed in South San at the end of our presentation we would like to give you a copy of our proposals which were presented to Dr. Saavedra at last month's district consultations meeting. Currently there are three teacher salary schedules; South San AFT proposes the teachers on the 1st tier schedule should be merged onto the 2nd tier schedule. We also proposed a salary schedule to which you base many of our teacher population on; we are going to recommend that we base it on a conservative value, base on the Southwest ISD salary. As this district is very similar to Southwest on this current market. Our schedule is less than their schedule, and that is before they increase it any further a pay increase for next year, that should tell given you an idea on how far South San is. Our proposal also corrects the frozen steps both on tier 1 and tier 2 schedules, for tier 3 we request a 5% pay increase. An alternative proposal for teacher pay scale would be a 5% increase with another 1% allocated for adjustments to separate steps. We also request that a 10% pay increase for hourly employees with the added goal of reaching a living wage in the next few years. According the city of San Antonio the living wage is \$11.08 an hour, regarding stipends and supplemental pay requesting that they be restored now from the 30% cut from two years ago. Stipends and supplemental pay must be increase to market value and or the time spent on the duties. There also many sponsorship, clubs that are currently not covered with a stipend or supplemental pay and this should be considered as a change or an improvement for our district. Finally, South San will stop refusing state money meant to benefit South San; it's time to have a tax reauthorization election or TRE to begin receiving the 5.1 million dollars that the state would provi
