2. Discussion regarding auxiliary resignations, leaves of absence, retirements, and employment of new personnel/personnel returning from leaves of absence. (Tex. Gov't Code §§ 551.071 and 551.074).

Upon motion by Mrs. Tomlinson, seconded by Mr. Flores, the Board of Trustees voted Unanimously to approve the Superintendent's recommendation and appoint Angelica Garza as the Director of Student Assessment for the 2012-2013 contract year on a non-Chapter 21 contract, subject to the Superintendent's authority to assign and reassign as discussed in Closed Session.

5. Discussion regarding the appointment of the Chief of Police for the 2012-2013 school year, subject to assignment and reassignment as Recommended by the Superintendent. (Tex. Gov't Code §§ 551.071 and 551.074).

Upon motion by Mrs. Martinez, seconded by Mr. Flores, the Board of Trustees voted unanimously to approve the Superintendent's recommendation and appoint Eugene Tovar as the Chief of Police for the 2012-2013 school year on a non-Chapter 21 contract, subject to the Superintendent's authority to assign and reassign as discussed in Closed Session; and subject, further, to a negotiated contract to be approved by the Board.
