Upon motion by Mr. Savage, seconded by Mr. Mata, the Board of Trustees moved to approve the Interim Superintednet's recommendation and appoint Henry Yzaguirre as the Principal of South San Antonio High School Principal for the 2013-2014 school year, subject to assignment and reassignment by the Superintendent, on a term contract as discussed in closed session. 6/0 Motion carried.
