It doesn't seem possible that we are already to the end of the school year and that I have been Superintendent for five months.

I would like to take this opportunity to thank everyone for their continued support of the Eden Central School District. You again have made a difference in the lives of so many students by supporting not only the 2007-2008 School Budget, but also the propositions for new school buses and vehicles, a building project that will finally bring a new roof to our GLP School and a Capital Reserve Fund that will help us plan for the future and reduce the impact on taxpayers for future projects. Thank you!!

Please know that we all will continue to do our best for the students of the Eden Central School District while finding a real balance for what is best for our taxpayers. In an effort to make sure we can maintain this delicate balance, we have begun the process of reviewing all aspects of the District's operations and embarking on the lengthy process of developing a five year plan. This plan will encompass all aspects of our District, i.e. student achievement, finances, buildings and grounds, transportation, staff and extra class activities. Once completed, we will use the plan to chart our goals for the future. As this effort is taking place, we will continue our research into ways to improve student achievement, cost savings, program enhancement and collaboration with the town, other municipalities and school districts.

There is a great deal that each of us as members of the Eden Community can be proud of in this school District. Our students do well academically, our administrators, faculty and staff are some of the most dedicated in Western New York, our students are very well behaved and respectful, our parents are hard working and supportive, and our community is dedicated to helping us become the best school District in Western New York. The Business First Ranking again this year reflects this. The District ranked 18th out of 97 districts academically and 6th out of 97 in cost effectiveness. Our High School ranked 11th out of 127 schools, and the Middle School (grades 5-8 across two buildings) ranked 68th out of 207 schools. This year, Business First included all of the non-public schools in these rankings.

This is a great school District that we should all continue to be proud of!

At the May 17, 2007 Board of Education meeting, Mr. Buggs, the new District Superintendent, reported on the status/accomplishments of his first five months in the position. He offered the following list of accomplishments, plans, committees and communication efforts:

- ♦ AIS Academic Intervention Support Committee Completed work presented to Board.
- ♦ Web-site Committee Completed work presented to the Board.
- ♦ CDEP Comprehensive District Education Plan Committee Organized and began to work. This work will continue for the next 12-15 months. The committee will evaluate all aspects of student achievement data.
- ♦ Have maintained regular communication with the Board.
- ♦ Monthly District personnel newsletter.
- ♦ Writing a message to the community in each District newsletter.
- ♦ Weekly meeting with District administrators.
- ♦ Have given the opportunity to all staff in the Transportation Department, Administrators, Elementary School, GLP School, Business Office and Maintenance to meet with me one on one.
- ♦ Met with Glenn Nellis, Eden Town Supervisor. We will work to set up some areas of collaboration.
- ♦ Process of reviewing Shared Decision Making Team Plan underway.
- ♦ Working to complete Board, Superintendent Self-evaluation, as well as evaluating all members of the Administrative Team.
- ♦ Working to set up a process for developing additional parts of a five-year strategic plan outside of CDEP.
- ♦ Visit all of areas of District on a regular basis. Making every attempt to be visible throughout the District.
- ♦ Developed a well balanced, effective budget for 07-08. Will continue to review ways in which we can become more efficient doing what is best for kids.
- ♦ Continue to oversee all aspects of the Shared Decision Making Team Project #2.
- ♦ Developed a plan to bring the Superintendent's Office, Business Office and Pupil Personnel Services to one location to create better efficiency and teamwork.
- ♦ Reviewing all mandates for the State and Federal Education Departments to ensure that we are in compliance.
- ♦ Continuing to support curriculum and scheduling changes in all three schools to ensure that we maintain and increase excellent levels of student achievement.
- ♦ Working with administrators looking at ways to better showcase student work and achievement.
- ♦ Held two town meetings where each administrator shared information about their department and/or school. Will continue this format for next year.
- ♦ Worked with the Business Office staff to meet the needs and requests of the New York State comptroller's audit personnel.
- ♦ Meetings with town, administrators, and other district superintendents to brainstorm ideas and areas of effective collaboration.
- ♦ Set up/coordinated a 2.5 day administrative work session. Focusing on our mission, goals, hiring procedures, and effective evaluation of staff.
- ♦ Working to develop a plan for Board of Education in-service training to be presented in the fall of 2007.
- ♦ Worked out a collaborative plan with BOCES to share the services of our Director of Curriculum that will enhance her interaction with the New York State Education Department.
- ♦ Established a committee to develop a hiring practices handbook.
- ♦ Working to improve support of the PTA.

In addition, he thanked the Board of Education and the community for the opportunity to serve as the District Superintendent.

#### SCHEETZ SIGNS WITH MERCYHURST N.E.

Pitcher Nick Scheetz has recently signed a letter of intent to accept a scholarship offer and play baseball at Mercyhurst North East, a school competing in the NJCAA. Nick is a three year varsity player, not only pitching, but also playing outfield. As a pitcher, Nick has compiled a 12 and 3 record over the past three years. As a junior, Nick had a record of 6 and 1 with an ERA of 2.18 and totaled 57 strike outs in only 38 2/3 innings pitched. He posted a .391 batting average and contributed 13 RBI. This past off season, Nick worked to develop a slider and improve his off speed pitches to go along with his fastball, which tops out in the mid-eighties range. This season, Nick is 4 and 2 with 62 strike outs in 37 2/3 innings pitched. He currently sports a 2.23 ERA and has a .382 batting average with 14 RBI. Among his 21 hits this season are a double, triple, and two homeruns. Nick is the son of Donna and Gary Scheetz of Eden.

#### FREE AND REDUCED MEALS

Non-Discriminatory and Confidential By Shawn Johnson

The State of New York mandates that there is no physical segregation of, or any other discrimination against, any child because of his/her inability to pay the full price of a meal. The names of children eligible to receive free or reduced meals are not published, posted, or announced in any manner, and there is no overt identification of any such children by use of special tokens or tickets, or by any other means. Children eligible for free and reduced meals do not eat meals differently from the meals sold to children paying full price, go through separate lunch lines, or eat at separate times.

The District can approve applications with "no income", for up to 45 days. For example, health related emergencies where you are unable to work, changes in employment, or any other temporary financial hardships.



# IMMUNIZATION REQUIREMENTS FOR SCHOOL ENTRANCE/ATTENDANCE K-12

- 3 doses of Diphtheria toxoid containing vaccine (DTP, DTaP, DT) New York City requires 4 doses for Kindergarten only.
- 3 doses of Tetanus toxoid containing vaccine and Pertussis vaccine for children born on or after 1/1/05 (DTaP, DTP)
  - 3 doses of Polio vaccine (OPV and/or IPV)
- 2 doses of Measles vaccine and one dose each of Mumps and Rubella vaccines.
- The first dose of Measles, Mumps and Rubella vaccines (MMR) must be administered no more than 4 days prior to the first birthday.
  - 3 doses of Hepatitis B Vaccine (HBV)
- 1 dose of Diphtheria and Tetanus toxoid containing vaccine and acellular Pertussis vaccine for all children born on or after 1/1/94 who are enrolling in 6th grade.
  - 1 dose of Varicella vaccine.
- Administered no more than 4 days before the first birthday.
- Applies to all children born on or after 1/1/98 or children born on or after 1/1/94 who are enrolling in the 6th grade.

# IMMUNIZATION REQUIREMENTS FOR PRE-K

- 3 doses of Diphtheria toxoid containing vaccine (DTP, DTaP, DT) New York City requires 4 doses.
- 3 doses of Tetanus toxoid containing vaccine and Pertussis vaccine for children born on or after 1/1/05 (DTaP, DTP)
  - 3 doses of Polio vaccine ((OPV or IPV)
- 1 dose of Measles, Mumps, and Rubella vaccines (MMR)
- Administered no more than 4 days prior to the first birthday.

Hib (haemophilus Influenzae Type b) vaccine

- 3 doses before 15 months of age or
- 1 dose on or after 15 months of age
- 3 doses of Hepatitis B vaccine (HBV)

Pneumococcal vaccine for children born on or after 1/1/08

- 3 doses before 15 months of age or
- -1 dose on or after 15 months of age
- 1 dose of Varicella vaccine
- Administered no more than 4 days before the first birthday.



There is one volunteer who deserves special recognition this year, as it will be her last. Karen Pszonak has been a Parent Coordinator for the Publishing Company for all 12 years. She helped start and establish it. She will be passing the torch this year due to her last child moving on to third grade.

Twelve years ago, Marie Davern, the reading specialist at GLP at the time, brought the idea of "publishing" every child's written work or stories into books, to a group of teachers and parents. Tech Wars ECC 2007 showcased nine individual Technology based competitions for junior and senior high students. There were twenty-four local schools represented and over five hundred students attended the event.

Eden had ten students who entered the junior high bridge building/testing competition. Each of the following eighth grade students should be commended for their efforts: Derek Palmerton, Matt Kuppel, Josh Smith, Troy Neureuter, Justin Rich, Matthew Benedict, Cord Polzin and Zach Rice.

Two students in particular, Kyle Nagle, second place, and Kyle Zittel, first place, should be recognized for their outstanding achievement. Both eighth grade students actually competed in the high school division and still finished number one and two in the rankings.

The Battlebots team showcased thirteen brand new members this year.
