RECOMMENDED MOTION:** “that upon the recommendation of the Superintendent, **Jessica Maiorana**, who is initially certified in Students with Disabilities 1-6 and Childhood Education 1-6, be appointed as an Extended Leave Substitute Teacher, replacing Mrs. Amy Steger effective approximately April 11, 2015 through June 15, 2015 or upon the return of Mrs. Steger. **Salary is \$95 per day.**” (SA) (ENC)
