The Board will meet in a work session to plan for the allocation of District resources to support student learning in the 2021-2022 school year.


Tony Kingman, Chief Financial Officer, and Javier Guevara, SWBC Employee Benefits Consulting Group, were called to present and answer questions related to this item.
