**CITIZENS TO BE HEARD**

Mr. Rodriguez, Board President, read board meeting rules of decorum aloud.

Jose Pablo Arzola, Bexar County community activist and school board member advisor, addressed the Board regarding the posted agenda being in violation of both Texas Education Code and South San Antonio ISD Board Policy. He references a letter dated November 2, 2020, that was responding to a complaint submitted to TEA that referenced interference with the Superintendent and school governance. He stated that he is prepared to launch an investigation with TEA, as this is illegal. He stated that Trustees continue to micromanage, interfere and practice favoritism and nepotism. He stated again that this meeting is illegal.

**BOARD PRESIDENT'S REMARKS (NO ACTION / REPORT ONLY)**

Mr. Rodriguez addressed the Board and audience regarding misconceptions of the senior parade. He stated that he and Mrs. Alderete are a part of the Paws Up Committee. He said that this year was the 2<sup>nd</sup> annual senior parade, and was phenomenal. He stated that Mrs. Prado, Mr. Flores and Mr. Arrellano were in attendance. He informed that this is put on by the Paws Up Committee and is not a district sponsored event. He stated that the district including Mrs. Sendejo, Dr. Puig, and relevant staff, go above and beyond to accommodate

their requests so they are able to have the senior parade but everything else regarding sponsors, dates, routes, comes from the Paws Up Committee. He stated that Board members are invited to attend but have no input but hopes it to be an example of how more involved Board members, staff and community members can be. He said sometimes things happen that you have to accept and move forward. He said he remembered Mrs. Prado made pointed comments to Rey Saldana that encouraged what's transpiring today. He informed that the reason we are here today is because Mr. Arrellano delivered a letter sponsored by Mrs. Prado. Mr. Rodriguez read the memo aloud. Mr. Rodriguez read aloud the definition of coups d'état and stated that was what was going on. He referenced the special called meeting on May 12, 2021 when Dr. Puig's contract was extended. He read Mr. Flores' comments aloud from that night. He stated that there have been conversations amongst Board members where Mr. Arrellano will become Board President, Mr. Flores will remain Vice President, and Connie Prado will be Board Secretary.

Mr. Flores stated that Mr. Rodriguez was taking advantage of his position.

Mr. Rodriguez stated that Mr. Flores was out of order.

Mr. Rodriguez continued his remarks stating that he informed Dr. Puig that he was going to call the TEA. He stated that he did that on Sunday and had a detailed conversation with them. He stated that BBF Local is on Board member ethics. He stated that what we will see here tonight is not in the best interest of the district. He stated that he implored TEA in this crisis situation, to elevate our current monitor to a conservator. He stated that Dr. Puig is a phenomenal Superintendent and his body of work warranted an extension. He referenced a letter from a previous Superintendent to TEA. He stated that it justifies why there was a conservator. He said that the new board officers are going to micromanage the Superintendent. He stated that our Superintendent does need protection. He said he would go to any length to protect our kids. He stated what you are seeing here tonight is not focused on kids, it is focused on political power. He stated that this has lit another pilot in him and more passion to do what is right. He stated that this new board is not in favor of supporting West Campus HS. He stated that there is intent to tear West Campus down. He stated that we will see the puppet master fully and deliberately at work to attack Mr. Rodriguez. He stated that he was built for this and he came out ready for this. He stated if you are watching, I don't lose.

**DISCUSSION AND POSSIBLE ACTION**

Mr. Prado made a motion: I make a motion that we reorganize the board as follows: President Mr. Ernesto Arrellano, Vice President Mr. Homer Flores, and Secretary Ms. Shirley Ibarra, Ms. Ibarra seconded, and the Board of Trustees voted 5/2 to approve. Motion passed.
