#### SUPERINTENDENT'S REMARKS (NO ACTION / REPORT ONLY)

Dr. Marc Puig, Superintendent of Schools, addressed the Board and audience regarding growing enrollment and the wise decision of reopening Athens, Kazen, and West Campus. He stated that West Campus is bolstering academics, the arts, and athletics. He stated that the Elementary Secondary School Emergency Relief Fund will provide 28 million dollars and the district is seeking public input that's required to shape that federal grant. Dr. Puig informed the audience and board that the Texas Education Agency chose South San as one of the 50 schools to participate in the virtual and hybrid accelerated program. He provided a COVID 19 update; we have had zero transmissions originated on our campuses, we tested 3,300 kids and staff members this week for COVID 19, and nearly 100% of our staff are vaccinated that want to be vaccinated. Big events this weekend include an enrollment drive, vaccination drive, and a senior parade. South San High School graduation is on June 2 at 9 AM at the Alamodome. TASB has selected the Board to deliver training at SLI on June 17<sup>th</sup>.

#### **BOARD PRESIDENT'S REMARKS (NO ACTION / REPORT ONLY)**

Gilbert Rodriguez, Board President, addressed the Board and audience regarding 7 days left of the school year and the Board putting safety first. He thanked the Board for their commitment and for the resources that were allocated. He stated that we started receiving the preliminary EOC data and he looks forward to implementing the plan to address gaps. The senior parade is coming up, coordinated by the Paws Up committee. He informed that we wrapped up our visioning sessions. We will be presenting at SLI and have one more session for TASB XG. Mr. Rodriguez thanked our 2 foundations/committees that help our students district wide, Paws Up, and Cougar Pride foundation. He announced that Kelly and Marc Puig have contributed \$1,000 for each foundation for scholarships. He informed that we have our first annual alumni basketball tournament this weekend sponsored by out Cougar Pride foundation committee.
