#### NOW THEREFORE IT BE RESOLVED BY THE BOARD THAT:

- 1. All of the above-referenced paragraphs are incorporated into and made part of this Resolution;
- 2. The Board of Trustees has never authorized or approved the release of any written report of preliminary findings, as defined by Chapter 39 of the Texas Education Code, to the public;
- 3. The Board of Trustees has never authorized or approved the release of any associated materials, as defined by Chapter 39 of the Texas Education Code, to the public;
- 4. The Board of Trustees has never authorized or approved the release of any evidence, witness

- statements, or videos, as defined by Chapter 39 of the Texas Education Code, to the public.
- 5. The Board of Trustees hereby repudiates and disclaims any unauthorized and unlawful *ultra vires* actions including, but not limited to, the prohibited and unsanctioned release of documents, working papers, evidence, witness statements, or videos to the San Antonio Express News, or any other third person or third party.
