TEA REMARKS

Dr. Abe Saavedra, TEA: Thank you Mr. Lopez. Good evening Board members and Mr. Yzaguirre. Let me start my remarks by first of all correcting some of the misinformation. The appointment of a Conservator does not mean that the decisions are turned over to the Conservator. I've been at this point I've been assigned as Conservator at South San for about 2 months and I have yet to issue any directive. Every decision that's been made by this Board in the last 2 months has stood without any kind of correction. So any implication that the decisions of the district have been turned over to the TEA is incorrect. I also want to, Mike would you put up the one slide? I also want to talk to you a little but about the finances because you've been misinformed there as well. What you have, what you have in front of you on the screen is a cost trend line analysis that I requested several weeks back from the CFO Mr. Kingman. On the left hand side is the year, those are the fiscal years starting 2012-2013 school year and going all the way through the 2023-2024 school year. Column A will be your revenue, Column B is your expenditure, Column C is either your surplus or deficit, Column D would be the general fund expenditure E would be the ESSER money that was used to cover deficits. And the final Column F would be the total ESSER expenditures. The line graph you see, which is the blue and the red, below that, would follow the years 2012-2024. The red line would be the expenditures the blue being the revenue. That line graph shows you as a Board that as far back as 2012 the district was spending less money than the revenue it was bringing in. The surplus revenue goes into fund balance. The reason the district has a healthy fund balance at this point is that from 2012-2019 the district spent less money than what it was bringing in. Again the surplus going into reserves. In 2019, two things happened; schools get reopened and for the first time in several years the district crosses over into the red. That's where you see the red line crossing the blue exactly at the same year. And that deficit has continued up to this point. And so I would suggest to you that there is some

correlation between the existing deficit that the district has and the reopening of those schools. I know that the decision that you have tonight is a difficult one for the Board, for the community, really for anyone involved. One gentleman earlier said you need to look at the numbers. That's exactly what I suggest you do; is this district cannot continue to overspend the level of revenue that comes in. If you do that, it will not be long before the district goes through the existing fund balance and basically become broke completely as a district, financially broke. So something needs to happen, the responsibility is not mine as a Conservator. The responsibility belongs to you as a Board. Thank you.
